Following an inspection on Tuesday 19th March, parts of the sprint course were found to be unfit for racing following heavy rain and some remedial work during the Winter months and the **3 Sprint Races were cancelled**.

Irish Horseracing Regulatory Board

The Directors of the IHRB, at their Board Meeting on March 6, 2024 approved the following changes to Rule 96 (i) and Rule 148(xi)(d) which will become effective on April 1, 2024:

Adverse Analytical Findings in Equines

96. (i) When a Horse has been examined or tested and Samples taken pursuant to Rule 18 and such examination or test or an analysis of such Samples shows the presence of any Prohibited Substance, unless the concentration of the Prohibited Substance is below the threshold level for that substance (if any) as set out in the Schedule of Prohibited Substances available on the IHRB website, it shall be a breach of these Rules and the Referrals Committee or the Appeals Body as the case may be, [text deleted] shall direct that:

- the Horse be restricted from running for such time as it shall determine;
- the Horse be disqualified [text

deleted] from the Race(s) in question, the placings amended and the stake forfeited;

- the Trainer of the Horse be fined not less than €1,000; and/or
- the Trainer's licence be withdrawn for such period as it may consider appropriate.

[Text deleted]

It shall not be a defence that the Prohibited Substance was administered under the supervision of a Veterinary Surgeon as part of a course of treatment prescribed by the Veterinary Surgeon or that the administration of the Prohibited Substance ceased at a time recommended by the Veterinary Surgeon.

148 (xi) (d)

When a Horse trained in Ireland runs in a Race outside of [text deleted] Ireland or Great Britain, the Trainer must notify the Registry Office of the details of such Racecourse performance. This notification must be lodged within 48 hours of the Race being run or, before the Horse is subsequently entered for any Race, whichever is the earlier. Failure to do so will result in the Trainer being liable to a fine of not less than €130.

Appeals & Referrals

Appeal

The Appeals Body, Mr Peter Law (Chairperson), Mr John Murphy and Mr Anthony Byrnes convened at the Offices of the Irish Horseracing Regulatory Board on Tuesday, 19 March 2024 to consider the appeal of Philip Byrnes (Rider) against the decision of the Raceday Stewards at Navan on Saturday, 2 March 2024.

Following the running of the Boylesports Extra Places Handicap Hurdle, the Raceday Stewards found Mr Burns, rider of Aodhan May, in breach of Rule 214, in that he had ridden carelessly and having considered his record in this regard they suspended him for four racedays.

The grounds of appeal lodged by Mr Byrnes was that the Stewards on the day erred in their decision.

At the Appeal Hearing, evidence was heard from Mr Byrnes and Shane Fenelon, rider of Carrig Carol in the same race. The Appeals Body also watched a recording of the race.

In his evidence, Mr Byrnes stated that he retained his racing line three off the rail while rounding the bend and Mr Fenelon, who was on his inside, tried to go for a gap that, in his

opinion, wasn't there. Mr Byrnes also clarified his evidence on the day as meaning he was attempting to stay on the inside of Chosen Diamond, ridden by Sean O'Keeffe, rather than that he was riding to get on his inside.

In his evidence Mr Fenelon explained that he was riding two off the rail and the horse on his inside had clipped the railing right on the point of the bend. Mr Fenelon stated that he felt pressure from Mr Byrnes on his outside, but this was most probably due to the fact they were rounding the bend at the time, and he gave a precautionary shout but felt any interference was minimal in nature.

Having considered the evidence, the Appeals Body allowed the appeal.

The appeal was presented by Mr Andrew Coonan of Coonan Cawley Solicitors, Naas, County Kildare, on behalf of Mr Byrnes. The IHRB was represented by Mr Andrew Ring, IHRB Stipendiary Steward and Ms Clíodhna Guy, Head of Licensing, Legal and Compliance.

Appeal

The Appeals Body, Mr Peter Allen (Chairperson), Mr N.B. Wachman and Dr Paddy Molony convened at the Offices of the Irish Horseracing Regulatory Board on Wednesday, 20 March 2024 to consider the appeal of Wayne Hassett (Rider) against the decision of the Raceday Stewards at Dundalk on Friday, 8 March 2024.

Following the running of the CT1 Apprentice Handicap, the Raceday Stewards found Mr Hassett, rider of Anjah, in breach of Rule 214, in that he had ridden carelessly and having considered his record in this regard they suspended him for 20 racedays.

The grounds of appeal lodged by Mr Hassett was that the Stewards on the day erred in their decision.

At the Appeal Hearing, evidence was heard from Mr Hassett and Mr Niall McCullagh, Jockey Coach to Mr Hassett. The Appeals Body also watched a recording of the race.

In his evidence, Mr Hassett explained that while coming into the straight, his mount was leaning to the right slightly and he tried to correct him but being a seasoned handicapper as he was correcting the horse he horse ducked for the paddock gate. Mr Hassett added that he did everything in his power to keep him straight and once he passed the gate his mount straightened up.

In his evidence, Mr McCullagh explained that Mr Hassett had used corrective measures and did everything in his power to straighten his mount but it was just not possible for him to prevent his mount from lugging towards the gate from half way up the straight.

Having considered the evidence, the Appeals Body allowed the appeal. The appeal was presented by Mr Kevin Power, Maurice Power Solicitors, Kilmallock, Co. Limerick, on behalf of Mr Hassett. The IHRB was represented by, Mr Colman Sweeney IHRB Stipendiary Steward and Ms Clíodhna Guy, Head of Licensing, Legal and Compliance.

Appeal

The Appeals Body, Mr Peter Allen (Chairperson), Mr N.B. Wachman and Dr Paddy Molony convened at the Offices of the Irish Horseracing Regulatory Board on Wednesday, 20 March 2024 to consider the appeal of Mr H.C. Swan, Mr R. James, Miss G. Benson, Mr F. Maguire, Mr A. Harvey, Mr J.L. Gleeson, Mr B.M. Coonan, Mr A.P. Ryan and Mr P. Hanlon (Riders) against the decision of the Raceday Stewards at Dundalk on Friday, 1 March 2024.

Following the running of the Peter K. Hits The Big 50 (Q.R.) Handicap, Mr H.C. Swan, rider of Riyami, Mr R. James, rider of Arabian King, Miss G. Benson, rider of Caulaincourt, Mr F. Maguire, rider of Eskimo Comet, Mr A. Harvey, rider of Rockview Consort, Mr J.L. Gleeson, rider of Liberated Light, Mr B.M. Coonan, rider of Tudor City, Mr A.P. Ryan, rider of Next Week and Mr P. Hanlon, rider of Liquid Metric, were all found to be in breach of Rule 212A.(ii) by the Raceday Stewards as it appeared that Wrecking Ball Paul ridden by Mr K.P. Healy was given an unassailable lead before going on to win by 15 lengths. Having taken the record of each individual rider in this regard into account, the Raceday Stewards suspended each of the above-named riders for five racedays.

The grounds of the appeal lodged by each rider was that the Raceday Stewards erred in their decision.

At the appeal hearing evidence was heard from Mr Swan, Miss Benson, Mr Maguire, Mr Harvey, Mr Gleeson, Mr Coonan, Mr Ryan and Mr P. Hanlon and submissions were made on behalf of Mr James by Kevin Powe, solicitor. Evidence was also heard from Mr Andrew Slattery, trainer of Next Week, Mr Anthony McCann, trainer of Liquid Metric and Mr Garry O'Gorman, IHRB Senior Flat Handicapper. The Appeals Body also watched a recording of the race.

In his evidence, Mr Swan stated that he was riding to instructions from Mr Denis Hogan, trainer of Riyami to drop out and get cover. Mr Swan explained this is how the horse was ridden on his previous run, however, as he was out the back, he found no opportunity to move forward.

In her evidence, Miss Benson stated that her mount ran keen on his previous start at Dundalk, and she was instructed to settle her mount and sit in mid division. Miss Benson added that she was conscious to keep a horse in front of her and admitted she didn't realise how far Wrecking Ball Paul had gone in front.

In his evidence, Mr Maguire stated that his mount predominantly races over distances from a mile to a mile and two furlongs and it was his first occasion stepping up in trip. Mr Maguire added that he was mindful of conserving as much energy as possible to finish out the race and achieve the best position as he was unsure about his horse over this trip.

In his evidence, Mr Harvey stated that he was instructed by Mr John McConnell, trainer of Rockview Consort to drop out and get him settled as she was keen on her previous run. Mr Harvey added that during the last furlong, his mount couldn't gain any more ground and if he had of increased the pace earlier, they would have finished further back.

In his evidence, Mr Gleeson stated that he was instructed by Mr John Kiely, trainer of Liberated

Light to drop his mount towards the back and get cover as he was drawn wide. Mr Gleeson explained that he made every effort to follow instructions and achieve the best possible placing for his horse.

In his evidence, Mr Coonan stated it was his first ride at Dundalk and he was instructed to get cover and get to the rail, as his mount just about sees out two miles. Mr Coonan also suggested his mount was a doubtful stayer therefore, he wanted to conserve as much energy as possible to finish out the race. In his evidence, Mr Ryan stated that his mount had previously missed the break and he was under strict instructions from Mr Slattery, to get his mount to settle and finish out the race.

In his evidence, Mr Hanlon stated that it was his first-time riding at Dundalk, and he was instructed by Mr McCann, to jump out and get the horse settled. Mr Hanlon added it was Liquid Metric's first time over two miles on the Flat. In his evidence, Mr McCann confirmed the instructions given to Mr Hanlon and explained the horse is a low-grade type and he believed he ran well taking his previous record into account.

In his evidence Mr Slattery suggested that Dundalk is a track that takes some getting used to and he believes this race developed into a freak situation. Mr Slattery confirmed the instructions given to Mr Ryan and explained his horse has a tendency not to settle and run keen.

In his evidence, Mr O'Gorman stated that the sectional timings corroborated with the visuals on the night in that the winner obtained a clear advantage and the race was over a long way out. Mr O'Gorman explained that the winner, Wrecking Ball Paul, is free running and he felt the race was over half a mile from home. Mr O'Gorman added that a race being run like this was rare but can happen occasionally.

Having considered the evidence, Mr Allen on behalf of the Appeals Body acknowledged the decision of the Raceday Stewards on the night and stated that with the benefit of increased time to review the footage, more time to consider the evidence and the mitigating factors they allowed the appeals.

Mr Swan, Mr James and Miss Benson were represented by Kevin Power of Maurice Power & Co Solicitors, Limerick. Mr F. Maguire, Mr A Harvey and Mr J.L. Gleeson were represented by Stephen Lanigan O'Keefe S.C.. Mr B.M. Coonan and Mr A.P. Ryan were represented by Andrew Coonan of Coonan Cawley Solicitors and Mr Hanlon represented himself at the hearing. The IHRB was represented by Ms Clíodhna Guy, Head of Licensing, Legal and Compliance and Mr Colman Sweeney, IHRB Stipendiary Steward.

Appeal

The Appeals Body, Mr Peter Allen (Chairperson), Mr N.B. Wachman and Dr Paddy Molony convened at the Offices of the Irish Horseracing Regulatory Board on Wednesday, 20 March 2024 to consider the appeal of Jack Kearney (Rider) against the decision of the Raceday Stewards at Dundalk on Friday, 8 March 2024.

Following the running of the Ross Clair Maiden, the Raceday Stewards found Mr Kearney, rider of Hoover Dam in breach of Rule 214, in that he had ridden carelessly and having considered

his record in this regard they suspended him for four racedays.

The grounds of appeal lodged by Mr Kearney was that the Stewards on the day erred in their decision.

At the Appeal Hearing, evidence was heard from Mr Kearney. The Appeals Body also watched a recording of the race.

In his evidence Mr Kearney explained that he was trying to move towards the outside rail and added that initially he left adequate room along the rail for Rory Cleary, rider of Spunog. However, Mr Kearney stated that he was taken off his racing line by Al Mudhaffar, ridden by Dylan Browne McMonagle, who was also moving towards the rail. Mr Kearney suggested that if he was able to maintain his racing line this incident wouldn't have occurred.

Having considered the evidence, the Appeals Body dismissed the appeal and confirmed the suspension of four racedays.

The appeal was presented by Mr Kevin Power, Maurice Power Solicitors, Kilmallock, Co. Limerick, on behalf of Mr Kearney. The IHRB was represented by, Mr Colman Sweeney IHRB Stipendiary Steward and Ms Clíodhna Guy, Head of Licensing, Legal and Compliance.

However, Dr Adams reported to the Raceday Stewards that on inspecting Longhouse Poet he noticed what appeared to be a venepuncture of the left jugular vein with fresh blood that had not been seen when the animal was presented for inspection and microchip scanning prior to racing. Evidence was heard from Dr. Adams and from Mr. Brassil. Mr. Brassil stated that Duphalyte was administered to the animal the previous evening by their own Veterinary Surgeon, which accounted for the puncture wound. *Dr Adams stated that following his initial post-race inspection of Longhouse Poet there was no evidence of blood, however as the horse was walking around to cool down fresh blood was then noticed. He acknowledged that the mark on the horse could be associated with the administration of Duphalyte, however, he said that it would be unusual to see fresh blood at this point. Dr. Adams confirmed that there was no evidence of equipment for giving intravenous injections following an examination of the stables, kit bags and horse box.* Having considered the matter, the Raceday Stewards noted the explanation given and ordered that a full post-race sample be taken from Longhouse Poet for further analysis.
