An I.N.H. flat race for four and five yrs old only that have not won a *race other than one, two or three I.N.H. flat races or National Hunt flat races or a combination of such races and which had been catalogued and offered in the Tattersalls Ireland May Sale of May 15th, 2018 or the Tattersalls Ireland Derby Sale of June 27th & 28th 2018 or the Tattersalls Ireland August National Hunt Sale of August 14th, 15th & 16th, 2018 and have been declared by Tattersalls Ireland Ltd. as being eligible to enter and run in accordance with the relevant Conditions of Sale.

Horses which do not have a registered name and are not Returned In Training with a Licensed Trainer by Wednesday, 6th March, 2019 will be automatically struck out of this race. (Please note for Irish and British bred horses, trained in Ireland, an acceptable naming application should be made to HRI by Thursday, 28th February, 2019 at the very latest. For all other foreign bred horses, trained in Ireland, naming applications will take longer to process).

 €300 (plus €42.50 bookage fee) extra if forfeit not declared by 21st November 2018,
 €200 (plus €42.50 bookage fee) extra if forfeit not declared by 13th February, 2019,
 €100 (plus €42.50 bookage fee) extra if forfeit not declared by 16th April, 2019.
 Weights: 4-y-o 11st 4lb; 5-y-o 12st
 Mares allowed 7lb

Riders - Qualified Riders under I.N.H.S. Rules. Allowances to riders under Rule 52 (iii) may be claimed in this race. *Including races under any National Hunt Rules or Rules of Racing. HRI Directive 10 (ii) (c) is suspended for the purpose of this race. The Stewards of the I.N.H.S. Committee, using their powers under Rule 22 have suspended the appropriate paragraphs of Rules 103 (i), 106, 121 and 122.

Not more than twenty five horses may be permitted to run in this race and there may be three reserves.

Should it be necessary to reduce the number of declared runners to that number or to such a lesser number that the Stewards may decide, the following procedures shall be applied for the elimination and balloting of horses:-

(i) Runners will first be reduced by balloting from among those horses that have not run in an INH Flat race, a National Hunt Flat race, a Hurdle race or a Point-to-Point Steeplechase in Ireland or Great Britain prior to Tuesday, 16th April, 2019. (ii) In the event of (i) not achieving the recommended limit, runners will then be reduced by balloting from among those horses that have not been placed first, second, third, fourth or fifth in an INH Flat race or National Hunt Flat race, second, third, fourth or fifth in a Hurdle race or first, second, third or fourth in a Point-to-Point Steeplechase in Ireland or Great Britain prior to 16th April, 2019, with the order of elimination at the discretion of the N.H. Handicapper. (iii) In the event of (ii) not achieving the recommended limit, the elimination of the remaining runners will be at the discretion of the N.H. Handicapper. The Handicapper's decision shall be final. (International performances will be taken into account and the latest date for assessment by the Handicapper will be 10 a.m. on Tuesday, 16th April, 2019).

N.B. The entry and forfeit fees will be refunded to the owners of those horses that are eliminated from this race.

The winning Owner, Trainer and Rider will receive a trophy of no intrinsic value presented by Tattersalls Ireland Ltd., who will also present €150 to the groom in charge of the best turned out horse and €150 to the groom in charge of the winning horse in this race.

Owners who do not have a current racing account should include cheque for €412.50 (including bookage fee of €12.50) for each entry.
