Important Notice to Trainers – CITY OF YORK STAKES (Group 1)

Trainers are strongly advised to note the
following update for the City of York Stakes
(Group 1) at York on Saturday 23rd August:

**NOTE: Horses will only be eligible to run in
this race provided that they have a current
BHA Handicap Rating of 80 or higher at
midday of the confirmation stage.**

**Horses which do not qualify for a rating may
also be eligible providing the BHA
Handicapper is satisfied that the horse's
racecourse performances up to and
including the day before confirmation merit
a provisional assessment of 80 or higher.
Horses which have not run will not be
eligible.**

Declaration Of Non-Runners & Reserves

Trainers are requested to note that notifications
of a non-runner or declaration of a reserve **can
now be done via RAS** or on the dedicated
telephone line (045-445645) at the Office of the
I.H.R.B. up to 90 minutes before the time of the
first race.

If using the Non-Runner/Reserve Telephone
Line, the caller will be asked to provide the
Trainer's Horse Racing Ireland account number
and Trainer's date of birth. All calls are recorded
for verification and security purposes.
Veterinary certificates, where required, must be
sent as usual to the Office of the IHRB within 72
hours. A Trainer failing to lodge a certificate
within the time period shall be liable to a fine in
accordance with Rule 194(v)(vi).

Trainers wishing to declare a Reserve a runner
or a non-runner must also do so **via RAS** or on
the same dedicated telephone line number by
**10am for meetings, (other than floodlit
meetings) during the months of November,
December and January** and by 11am for all
other meetings including floodlit meetings
otherwise the reserve will automatically be
withdrawn.

If a rider has not been nominated for a declared
reserve the Trainer must do so by the time fixed
for declaration of a reserve listed within the
paragraph above otherwise the declared
reserve will automatically be withdrawn.

**Declaration of reserves or of non-runners
are no longer accepted at a race meeting.**

Updates can be made **via RAS anytime after
the publication of Rider Nominations for the
meeting up to the specified deadlines.**

The dedicated line number (045 - 445645) is in
operation from 9am on weekdays when there is
a Race Meeting **and from 8.30am on
weekends and Bank Holidays in November,
December and January.**

Appeals & Referrals

Referral

The Referrals Committee, Mr Martin P
O'Donnell (Chairman), Mr John Murphy and Mr
Anthony Byrne convened at the Offices of the
Irish Horseracing Regulatory Board on
Wednesday, 18 June 2025 to consider a referral
from an IHRB Senior Racing Official in relation
to the identification of Jet To Glory, trained by
Harley Dean Dunne, who was due to run at the
Co. Limerick (F) Athlaca Point to Point fixture
on Sunday 6 April 2025.

On the day, the Acting Stewards received a
report from Mr Anthony Ryan, IHRB Veterinary
Officer, that Susan Scott, IHRB Official was
unable to positively identify Jet To Glory as
there was a discrepancy with the microchip
number in the horse presented to run and the
microchip list containing all microchips for
runners at the fixture. Mr Ryan added that the
microchip scanned in the horse presented

appeared to be that of an unnamed 4yo filly by
Jet Away x Curragh Na Gold. The Acting
Stewards ordered the withdrawal of the horse
from the race and referred the matter to a
Senior Racing Official for further investigation, a
blood sample was also taken by Mr Ryan for
DNA Analysis.

At the Referrals Committee hearing, evidence
was heard from Mr Dunne.

In his evidence, Mr Dunne apologised for the
misunderstanding and accepted he was in
breach of the rules for presenting the wrong
horse on the day. Mr Dunne explained that in
the summer of 2024 he viewed a number of
horses in a field which included two three-year-
old chestnut fillies, both by Jet Away. Mr
Dunne believed he chose the three-year-old Jet
Away x Lilys Glory filly. Mr Dunne accepted that
he did not check the identity of the filly on the
day in accordance with Rule 85 (vi).

Having considered the evidence, the Referrals
Committee found Mr Dunne in breach of Rule
85 (vi) and fined him €250.

The case was presented by Ms Christine
Traynor BL, IHRB Head of Racing Regulation
and Integrity.

Referral

The Referrals Committee, Mr Martin P
O'Donnell (Chairman), Mr John Murphy and Mr
Anthony Byrne convened at the Offices of the
Irish Horseracing Regulatory Board on
Wednesday, 18 June 2025 to consider a
referral of James W. Reilly (Handler) following
the Fermanagh (H) Necarne Point to Point
fixture on 9 May 2025.

On the day, the IHRB veterinary team reported
that Keogh Banjo had a second microchip
number reading which was not recorded in the
passport.

At the Referrals Committee hearing, evidence
was heard from Mr Reilly.

Mr Reilly apologised for the misunderstanding
and explained that Keogh Banjo was purchased
from the breeder with no passport and a late
registration was completed for a 2019 foal x
Presenting Kate based on the details received
from the breeder. Weatherbys subsequently
confirmed that that the 2018 foal sample
received was an exact match to the late
registration sample for what was assumed to be
a 2019 born foal. The breeder confirmed to
Weatherbys that Presenting Kate was covered
again by Policy Maker but did not produce a
foal in 2019 and the incorrect year of birth was
provided at the time of sale.

Having considered the evidence, the Referrals
Committee accepted the evidence of Mr Reilly
and did not find him in breach of any rules. The
Referrals Committee ordered that Keogh Banjo
was disqualified from the following three races:

Referral

The Referrals Committee, Mr Martin P O'Donnell (Chairman), Mr John Murphy and Mr Anthony Byrne convened at the offices of the Irish Horseracing Regulatory Board on Wednesday, 18 June 2025 to consider whether Miss Ellmarie Holden, (Trainer) was in breach of any rules of racing arising from a stable inspection carried out at her Training Establishment on 3 April 2024 by IHRB Officials.

On the day, the inspection team noted Jack's Jury was documented in the Medicines Register as having received Osphos on 5 March 2024 and ran in Quakerstown Point to Point on 31 March 2024 and the matter was referred under Rule 87(ii)(f). It was noted that Jet Setting Johnny and Karuma Grey (GER) were returned in training at the time of inspection but not present for inspection. Miss Holden reported they had been sold at Goffs in January and accepted that she had failed to return the Horses out of training.

Miss Holden accepted she was in breach of the rules.

Having considered the evidence, the Referrals Committee found Miss Holden in breach of Rule 87(ii)(f) and Rule 148(xii) and imposed a total fine of €500. The Referrals Committee ordered that Jack's Jury was disqualified from the following race:

The case was presented by Ms Christine Traynor BL, IHRB Head of Racing Regulation and Integrity.

Referral

The Referrals Committee, Mr Martin P O'Donnell (Chairman), Mr John Murphy and Mr Anthony Byrne convened at the offices of the Irish Horseracing Regulatory Board on Wednesday, 18 June 2025 to consider whether Mr Patrick Rooney was in breach of any rules of racing arising from a stable inspection carried out at his Training Establishment on 28 March 2024 by IHRB Officials.

On the day, the inspection team noted that the Medicines Register was not available for inspection in accordance with Rule 148 (ix).

In his submission, Mr Rooney accepted he was in breach of the rules and that he had taken measures to correct the situation.

Having considered the evidence, the Referrals Committee noted the corrective measures, acknowledged his acceptance and found Mr

Rooney in breach of Rule 148 (ix) and imposed a fine of €250.

The case was presented by Ms Christine Traynor BL, IHRB Head of Racing Regulation and Integrity.

Appeal

The Appeals Body, Mr Martin P O'Donnell (Chairman), Mr John Murphy and Mr Anthony Byrne convened at the Offices of the Irish Horseracing Regulatory Board on Wednesday, 18 June 2025 to consider the appeal of Robert Whearty (Rider) against the decision of the Raceday Stewards at Navan on 7 June 2025.

On the day, following the running of The Navan Racing Festival Early Bird Handicap, the Raceday Stewards found Mr Whearty, rider of Little Queenie, in breach of Rule 214 in that he had ridden carelessly and having considered his record in this regard (second offence), the Raceday Stewards suspended him for four racedays.

The grounds of the appeal lodged by Mr Whearty were that the Raceday Stewards erred in their decision on the day.

Evidence was given by Mr Whearty and Mr Niall McCullagh, Jockey Coach. The Appeals Body also watched a recording of the race. In his evidence, Mr Whearty accepted there was interference when his mount Little Queenie drifted right three to four strides from the finish line. However, Mr Whearty stated that, in his opinion, he had taken all reasonable steps to correct his mount, by applying pressure to the left rein and holding his whip in his right hand throughout the closing stages.

Having considered the evidence, the Appeals Body allowed the appeal believing the interference which occurred was accidental and did not arise from inattention or misjudgement.

The case was presented by Mr Whearty, accompanied by Mr Niall McCullagh, Jockey Coach. The IHRB was represented by Ms Christine Traynor BL, IHRB Head of Racing Regulation and Integrity and Mr Leighton Aspell, IHRB Stipendiary Steward.

Referral

The Referrals Committee, Mr Martin P O'Donnell (Chairman), Mr John Murphy and Mr Anthony Byrne convened at the offices of the Irish Horseracing Regulatory Board on Wednesday, 18 June 2025 to consider whether Mr Robbie Burns was in breach of any rules of racing arising from a stable inspection carried out at his Training Establishment on 8 May 2024 by IHRB Officials.

On the day, the inspection team noted that the Medicines Register was not available for inspection in accordance with Rule 148(iv) and Rule 148(vii).

In his submission, Mr Burns accepted he was in breach of the rules.

Having considered the evidence, the Referrals Committee found Mr Burns in breach of Rule 148(iv) and Rule 148(vii) and imposed a total fine of €500.

The case was presented by Ms Christine Traynor BL, IHRB Head of Racing Regulation and Integrity.

Referral

The Referrals Committee, Mr Martin P O'Donnell (Chairman), Mr John Murphy and Mr Anthony Byrne convened at the offices of the Irish Horseracing Regulatory Board on Wednesday, 18 June 2025 to consider whether Mr Thomas Gibney was in breach of any rules of racing arising from a stable inspection carried out at his Training Establishment on 21 June 2024 by IHRB Officials.

On the day, the inspection team noted Star Mood was Returned in Training but was not present. It was also noted that the last entries in the Medicines Register were recorded in 2022, with an updated Medicines Register later provided for Meyo (GB). Having considered the content of the stable inspection report, Mr Gibney was found to be in breach of Rule 148(xii), Rule 148(v) and Rule 148 (ix).

In his submission, Mr Gibney accepted he was in breach of the rules as set out and apologised for a delay in engaging with certain requests, citing personal circumstances as a factor in regard to some of the delays.

Having considered the evidence, the Referrals Committee noted the circumstances and acknowledged Mr Gibney's acceptance of being in breach of the rules. Mr Gibney was found in breach of Rule 148(xii), Rule 148(v) and Rule 148(ix) and imposed a total fine of €750.

The case was presented by Ms Christine Traynor BL, IHRB Head of Racing Regulation and Integrity.

This declaration is not considered as an entry. Trainers are to make their entries and other declarations directly online. They must also supply a complete race record of all the performances of the horse(s) entered on the Internet, by fax (33 1 47 61 93 37) or email (fgperf@france-galop.com). The entry will not be valid if these performances are not received by the international department at Racing Operations by the time of the first forfeit, or on the eve of the declaration to run (if entries were made more than a month before the race). When declaring a horse to run, it is the responsibility of the trainer to check the weight carried.

Italy - Owners and trainers of horses trained outside Italy are informed that, the first time they enter any horse to run in Italy, they must include with the entry the correct name, sex, year of foaling, pedigree (sire, dam and sire of dam) and the name of the country where the horse was foaled.
