## Important Notice – Hunters Certificates

Owners and Handlers of horses who wish to run at Mid Antrim (H) on Saturday 4<sup>th</sup> October and Westmeath (F) on Sunday 5<sup>th</sup> October should ensure that Hunters Certificates are lodged at the Office of the IHRB, The Curragh, Co. Kildare, R56 Y668 for registration **no later than close of business on Monday 15<sup>th</sup> September.**

Owners and Handlers of horses who wish to run at Route (H) on Saturday 11<sup>th</sup> October and Galway Blazers (F) on Sunday 12<sup>th</sup> October should ensure that Hunters Certificates are lodged at the Office of the IHRB, The Curragh, Co. Kildare, R56 Y668 for registration **no later than close of business on Monday 22<sup>nd</sup> September.**

## Irish Horseracing Regulatory Board Notice

### Declaration Of Non-Runners & Reserves

Trainers are requested to note that notifications of a non-runner or declaration of a reserve **can now be done via RAS** or on the dedicated telephone line (045-445645) at the Office of the I.H.R.B. up to 90 minutes before the time of the first race.

If using the Non-Runner/Reserve Telephone Line, the caller will be asked to provide the Trainer's Horse Racing Ireland account number and Trainer's date of birth. All calls are recorded for verification and security purposes. Veterinary certificates, where required, must be sent as

usual to the Office of the IHRB within 72 hours. A Trainer failing to lodge a certificate within the time period shall be liable to a fine in accordance with Rule 194(v)(vi).

Trainers wishing to declare a Reserve a runner or a non-runner must also do so **via RAS** or on the same dedicated telephone line number by **10am for meetings, (other than floodlit meetings) during the months of November, December and January** and by 11am for all other meetings including floodlit meetings otherwise the reserve will automatically be withdrawn.

If a rider has not been nominated for a declared reserve the Trainer must do so by the time fixed for declaration of a reserve listed within the paragraph above otherwise the declared reserve will automatically be withdrawn.

**Declaration of reserves or of non-runners are no longer accepted at a race meeting.**

Updates can be made **via RAS anytime after the publication of Rider Nominations for the meeting up to the specified deadlines.**

The dedicated line number (045 - 445645) is in operation from 9am on weekdays when there is a Race Meeting **and from 8.30am on weekends and Bank Holidays in November, December and January.**

## Appeals & Referrals

### Appeal

The Appeals Body, Mr Peter Allen (Chairman), Mr M C Hickey and Mr Anthony Byrne convened at the Offices of the Irish Horseracing Regulatory Board on Tuesday, 5 August to consider the appeal of Jake Coen (Rider) against the decision of the Raceday Stewards at Killarney on 17 July 2025.

On the day, following the running of the Adare Manor Opportunity Handicap Hurdle, the Raceday Stewards found Mr Coen, rider of Swelltime, in breach of Rule 214, in that he had ridden carelessly and having considered his record in this regard (first offence), the Raceday Stewards suspended him for five racedays.

The grounds of appeal lodged by Mr Coen were that the Raceday Stewards on the day erred in their decision.

At the appeal hearing, evidence was heard from Mr Coen, Mr A Leahy rider of Party President, C M Hogan rider of Hees Dynamite, J G Gilligan rider of Gekkota (FR) and E M O'Sullivan rider of Minority Interest. The Appeals Body also watched a recording of the race.

In his evidence, Mr Coen stated that he was fully aware of the riders behind him and of Ethan O'Sullivan's position to his inside. Mr Coen stated that in his opinion he was clear of the other riders at all times and as he believed he was half a length clear, with his mount travelling

strongly he felt he had room to manoeuvre towards the rail.

In his evidence, Mr O'Sullivan said that he felt some pressure from his outside which caused him to take a check.

In his evidence, Mr Hogan accepted that he had to correct his mount as Mr Coen moved in towards the rail on rounding the bend but felt there was no interference and that no contact was made between their mounts.

In his evidence, Mr Leahy stated that he was trying to hold his position and while it was becoming tight to his inside, he did not receive any contact.

In his evidence, Mr Gilligan stated that as a result of Mr O'Sullivan correcting his mount Mr O'Sullivan and Minority Interest then found himself in his racing line and Gekkota then clipped a heel and was brought down.

Having considered the evidence, the Appeals Body upheld the decision of the Raceday Stewards to find Mr Coen in breach of Rule 214. Having considered Mr Coen's record, the Appeals Body imposed a suspension of three racedays.

The appeal was presented by Mr Patrick Kennedy, Patrick J O'Meara & Co Solicitors on behalf of Mr Coen. The IHRB was represented by Mr Leighton Aspell, IHRB Stipendiary Steward.

### Appeal

The Appeals Body, Mr N B Wachman (Chairman), Mr Anthony Byrne and Mr John Murphy convened at the Offices of the Irish Horseracing Regulatory Board on Tuesday, 12 August to consider the appeal of Adam Caffrey (Rider) against the decision of the Raceday Stewards at Galway on 2 August 2025.

On the day, following the running of the Ardilaun Hotel Handicap, the Raceday Stewards found Mr Caffrey, rider of Comfort Line, in breach of Rule 214 in that he had ridden carelessly and having considered his record in this regard (second offence), the Raceday Stewards suspended him for four racedays.

The grounds of the appeal lodged by Mr Caffrey were that the Raceday Stewards erred in their decision.

At the appeal hearing, evidence was heard from Mr Caffrey. The Appeals Body also watched a record of the race.

In his evidence, Mr Caffrey stated that as the riders were rounding the bend turning into the straight there was a pinch point in the race. Mr Caffrey explained that as a result of Zarahmmando, ridden by Andrew Slattery, moving in towards the rail that his mount and Reidh ridden by Oisín Orr, ran short of room. Mr

Caffrey added that he was not aware of Tai Tam Bay, ridden by Chris Hayes, on his inside at any stage, and Mr Hayes did not shout to make him aware that he was on his inside.

Having considered the evidence, the Appeals Body upheld the decision of the Raceday Stewards to find Mr Caffrey in breach of Rule 214. Having considered Mr Caffrey's record they imposed a suspension of four racedays.

The appeal was presented by Mr Caffrey in the company of Mr Niall McCullagh, Jockey Coach. The IHRB was represented by Ms Christine Traynor BL, IHRB Head of Racing Regulation and Integrity and Mr Leighton Aspell, IHRB Stipendiary Steward

### Appeal

The Appeals Body, Mr N B Wachman (Chairman), Mr Anthony Byrne and Mr John Murphy convened at the Offices of the Irish Horseracing Regulatory Board on Tuesday, 12 August to consider the appeal of Liam McKenna (Rider) against the decision of the Raceday Stewards at Galway on 3 August 2025.

On the day, following the running of the Adare Manor Opportunity Handicap Hurdle, the Raceday Stewards found Mr McKenna, rider of Battle of Ridgeway, in breach of Rule 214, in that he had ridden carelessly, and having considered his record in this regard (third offence), the Raceday Stewards suspended him for eight racedays.

The grounds of appeal lodged by Mr McKenna was that general bunching took place however, he did not cause interference.

At the appeal hearing, evidence was heard from Mr McKenna. The Appeals Body also watched a recording of the race.

In his evidence, Mr McKenna stated that having cleared the hurdle passed the stands he gradually made his way towards the rail. Mr McKenna said that he was not aware of any interference at any point and that at no point did he feel there was a need for him to correct his mount. Mr McKenna added that he felt the incident was a result of general bunching but not the cause of his mount or anything he had done.

Having considered the evidence, the Appeals Body allowed the appeal believing that the interference that occurred was not as a result of careless riding by Mr McKenna.

The appeal was presented by Mr Andrew Coonan, Coonan Cawley Solicitors on behalf of Mr McKenna. The IHRB was represented by Ms Christine Traynor BL, IHRB Head of Racing Regulation and Integrity and Mr Leighton Aspell, IHRB Stipendiary Steward.

### Appeal

The Appeals Body, Mr N B Wachman (Chairman), Mr Anthony Byrne and Mr John Murphy convened at the Offices of the Irish Horseracing Regulatory Board on Tuesday, 12 August to consider the appeal of Sean Cleary Farrell (Rider) against the decision of the Raceday Stewards at Galway on 3 August 2025.

On the day, following the running of the Adare Manor Opportunity Handicap Hurdle, the

Raceday Stewards found Mr Cleary Farrell, rider of Miss Dishy, in breach of Rule 214, in that he had ridden carelessly and having considered his record in this regard (first offence), the Raceday Stewards suspended him for two racedays.

The grounds of the appeal lodged by Mr Cleary Farrell were that he did not ride carelessly and took all reasonable and permissible measures to avoid interference occurring.

At the appeal hearing, evidence was heard from Mr Cleary Farrell. The Appeals Body also watched a recording of the race.

In his evidence, Mr Cleary Farrell stated that he was aware of an incident on his inside before he felt any contact. Mr Cleary Farrell said that he took action as quickly as he could to keep his mount away from the situation as soon as he heard shouting from another rider. Mr Cleary Farrell added, in his opinion, the incident was as a result of things getting tight on his inside and not by him.

Having considered the evidence, the Appeals Body upheld the decision of the Raceday Stewards to find Mr Cleary Farrell in breach of Rule 214. Having considered Mr Cleary Farrell's record, the Appeals Body imposed a suspension of two days.

The appeal was presented by Mr Andrew Coonan, Coonan Cawley Solicitors on behalf of Mr Cleary Farrell. The IHRB was represented by Ms Christine Traynor BL, IHRB Racing Regulation and Integrity and Mr Leighton Aspell, IHRB Stipendiary Steward.

### Horse Racing Ireland Directives:

**The Directors of Horse Racing Ireland have approved the following modifications to HRI Directives 4 & 10 to come into effect in October 2025.**

#### HRI DIRECTIVE 4

**Race Conditions for I.N.H. Flat Races:**

#### 3. Qualification

A horse shall not be qualified to start for an I.N.H. flat race if:

- It has run in a Flat race or Steeplechase.
- It has run in a Hurdle race as a three year old (**excluding Academy Hurdles or 3-y-o Junior N.H. Hurdle Races**)
- It has run in more than two Hurdle races.
- It has won a Hurdle race (**excluding Academy Hurdles or 3-y-o Junior N.H. Hurdle Races**)

#### HRI DIRECTIVE 10

**Elimination and Balloting out of Horses:**

#### 4. In Weight For Age National Hunt Races (excluding Pattern/Listed Races)

##### 4.1 Steeplechases (other than Beginners Steeplechases)

Protection from balloting will operate in the following order:

- Horses which have won a Grade 1, 2 or 3 Weight For Age National Hunt race run under the Rules of any Recognised Turf Authority.
- Horses which have won a Steeplechase run under the Rules of any Recognised Turf Authority and which do not have an official Steeplechase rating in Ireland.
- Horses which have won a Steeplechase run under the Rules of any Recognised Turf Authority and which have an official Steeplechase rating in Ireland, the highest rating affording the greatest protection.
- Horses which have an official Steeplechase rating in Ireland of 115 or more, the highest rating affording the greatest protection.
- Horses which have won a Hurdle race, an I.N.H. Flat race, or a National Hunt Flat race run under Rules of any Recognised Turf Authority and which were placed 2nd, 3rd, 4th or 5th in either of their last two completed Steeplechases run in Ireland.
- Horses which have won a Hurdle race (**excluding Academy Hurdles or 3-y-o Junior N.H. Hurdle Races**) run under the Rules of any Recognised Turf Authority and which have completed in less than three Steeplechases run in Ireland.
- Horses which have won an I.N.H. Flat race or a National Hunt Flat race under the Rules of any Recognised Turf Authority and which have completed in less than three Steeplechases run in Ireland.
- Horses which have won an Academy Hurdle or 3-y-o Junior N.H. Hurdle Race and which have completed in less than three Steeplechases run in Ireland.**
- Horses placed 2nd 3rd, 4th, or 5th in either of their last two completed Steeplechases run in Ireland.**
- Horses which have completed in three or more Steeplechases run in Ireland and to which the handicapper is not prepared to allocate an official Steeplechase rating in Ireland.**
- Horses which have completed less than three times in steeplechases run in Ireland.**
- Horses which have the highest official Steeplechase rating in Ireland below 115 at time of entry, the highest rating affording the greatest protection.**

Note: When protection is equal, horses previously balloted/eliminated from a Steeplechase run under I.N.H.S. Rules, on or subsequent to 180 days prior to the date of the preliminary ballot will be protected from balloting first, the latest

ballot/elimination date at the time of the preliminary ballot stage affording greatest protection. If it is necessary to ballot among horses of equal protection, such ballot will be random. For the purposes of Section (4.1) above, 'pulled up' will be considered a completed run.

#### 4.2 Beginners Steeplechases

Protection from balloting will operate in the following order:

- a. Horses which have won a Grade 1, 2 or 3 Weight for Age National Hunt race run under the Rules of any Recognised Turf Authority and which have completed in less than three Steeplechases run in Ireland.
- b. Horses which have an official Steeplechase rating in Ireland of 115 or more, the highest rating affording the greatest protection.
- c. Horses placed 2nd, 3rd, 4th or 5th in either of their last two completed weight-for-age Steeplechases run in Ireland.
- d. Horses which have won a Hurdle race (excluding Academy Hurdles or 3-y-o Junior N.H. Hurdle Races) run under the Rules of any Recognised Turf Authority and which have completed in less than three Steeplechases run in Ireland.
- e. Horses which have won a I.N.H. Flat race or a National Hunt Flat race under the Rules of any Recognised Turf Authority and which have completed in less than three Steeplechases run in Ireland.
- f. Horses which have won an Academy Hurdle or 3-y-o Junior N.H. Hurdle Race and which have completed in less than three Steeplechases run in Ireland.
- f g. Horses which have completed in two, three or four Steeplechases run in Ireland and to which the handicapper is not prepared to allocate an official Steeplechase rating in Ireland.
- g h. Horses which have completed less than three times in Steeplechases run in Ireland.
- h i. Horses which have the highest official Steeplechase rating in Ireland below 115 at time of entry, the highest rating affording the greatest protection.
- i j. Horses which have completed five or more times in Steeplechases run in Ireland and do not have an official Steeplechase rating in Ireland.

Note: When protection is equal, horses previously balloted/eliminated from a Steeplechase run under I.N.H.S. Rules, on or subsequent to 180 days prior to the date of the preliminary ballot will be protected from balloting first, the latest

ballot/elimination date at the time of the preliminary ballot stage affording greatest protection. If it is necessary to ballot among horses of equal protection, such ballot will be random. For the purposes of Section (4.2) above, 'pulled up' will be considered a completed run.

#### 4.3 Hurdles (other than Maiden Hurdles)

Protection from balloting will operate in the following order

- a. Horses which have won a Grade 1, 2 or 3 Weight For Age National Hunt race or a Group 1, 2 or 3 Flat race run under the Rules of any Recognised Turf Authority.
- b. Horses which have won a Hurdle race (excluding Academy Hurdles or 3-y-o Junior N.H. Hurdle Races) run under the Rules of any Recognised Turf Authority and which do not have an official Hurdle rating in Ireland.
- c. Horses which have won a Hurdle race run under the Rules of any Recognised Turf Authority and which have an official Hurdle rating in Ireland, the highest rating affording the greatest protection.
- d. Horses which have won a an Academy Hurdle, a 3-y-o Junior N.H. Hurdle Race, an I.N.H. Flat race, or a National Hunt Flat race or a Flat race run under the Rules of any Recognised Turf Authority and which were placed 2nd, 3rd, 4th or 5th in either of their last two completed hurdle races run in Ireland.
- e. Horses which have won an I.N.H. Flat race or a National Hunt Flat race run under the Rules of any Recognised Turf Authority and which have completed in less than three hurdle races run in Ireland.
- f. Horses which have won an Academy Hurdle or 3-y-o Junior N.H. Hurdle Race which do not have an official Hurdle rating and which have completed in less than three Hurdle races run in Ireland.
- f g. Horses which have an official Hurdle rating in Ireland of 105 or more, the highest rating affording the greatest protection.
- g h. Horses placed 2nd, 3rd, 4th, or 5th in either of their last two completed Hurdle races run in Ireland.
- h i. Horses which have won a Flat race run under the Rules of any Recognised Turf Authority on or subsequent to January 1<sup>st</sup> of the year previous to the current year and which have completed in less than three hurdle races run in Ireland.

i j. Horses which have won a Flat race run under the Rules of any Recognised Turf Authority and which have completed in less than three Hurdle races run in Ireland.

j k. Horses which have completed in three or more Hurdle races run in Ireland and to which the handicapper is not prepared to allocate an official Hurdle rating in Ireland.

k l. Horses which have completed less than three times in Hurdle races run in Ireland.

l m. Horses which have the highest official Hurdle rating in Ireland below 105 at time of entry, the highest racing affording the greatest protection

Note: When protection is equal, horses previously balloted/eliminated from a Hurdle Race run under I.N.H.S. Rules, on or subsequent to 180 days prior to the date of the preliminary ballot will be protected from balloting first, the latest ballot/elimination date at the time of the preliminary ballot stage affording greatest protection. If it is necessary to ballot among horses of equal protection, such ballot will be random. For the purposes of Section (4.3) above 'pulled up' will be considered a completed run.

#### 4.4 Maiden Hurdles

Protection from balloting will operate in the following order:

- a. Horses which have won a Grade 1, 2 or 3 Weight for Age National Hunt race or a Group 1, 2 or 3 Flat race run under the Rules of any Recognised Turf Authority and which have completed in less than three Hurdle races run in Ireland.
- b. Horses which have an official Hurdle rating in Ireland of 115 or more at the time of entry (105 from 1<sup>st</sup> May to 30<sup>th</sup> September), the highest rating affording the greatest protection.
- c. Horses placed 2<sup>nd</sup>, 3<sup>rd</sup>, 4<sup>th</sup> or 5<sup>th</sup> in either of their last two completed weight-for-age Hurdle races run in Ireland (excluding Academy Hurdles or 3-y-o Junior N.H. Hurdle Races).
- d. Horses which have won an I.N.H. Flat race or a National Hunt Flat race run under the Rules of any Recognised Turf Authority and which have completed in less than three Hurdle races run in Ireland.
- e. Horses which have won an Academy Hurdle or 3-y-o Junior N.H. Hurdle Race and which have completed in less than three Hurdle races run in Ireland.

e **f.** Horses which have won a Flat race run under the Rules of any Recognised Turf Authority and which have completed in less than three Hurdle races run in Ireland.

g. **Horses placed 2<sup>nd</sup>, 3<sup>rd</sup>, 4<sup>th</sup> or 5<sup>th</sup> in an Academy Hurdle or 3-y-o Junior N.H. Hurdle Race in either of their last two completed Academy Hurdles or 3-y-o Junior N.H. Hurdle Races.**

g **h.** Horses which have completed in three, four or five Hurdle races run in Ireland and to which the handicapper is not prepared to allocate an official Hurdle rating in Ireland.

h **i.** Horses which have completed less than three times in Hurdle races run in Ireland.

i **j.** Horses which have the highest official Hurdle rating in Ireland below 115 at time of entry (105 from 1<sup>st</sup> May to 30<sup>th</sup> September), the highest rating affording the greatest protection.

j **k.** Horses which have completed six or more times in Hurdle races run in Ireland and do not have an official Hurdle rating in Ireland.

Note: When protection is equal, horses previously balloted/eliminated from a Hurdle race run under I.N.H.S. Rules, on or subsequent to 180 days prior to the date of the preliminary ballot will be protected from balloting first, the latest ballot/elimination date at the time of the preliminary ballot stage affording greatest protection. If it is necessary to ballot among horses of equal protection, such ballot will be random. For the purposes of Section (4.4) above, 'pulled up' will be considered a completed run.

#### 4.5 I.N.H. Flat Races

Protection from balloting/elimination will operate in the following order:

a. Horses which have won an I.N.H. Flat race or a National Hunt Flat race run under the Rules of any recognised Turf Authority.

b. Horses placed 2<sup>nd</sup>, 3<sup>rd</sup>, 4<sup>th</sup> or 5<sup>th</sup> in either of their last two completed runs in Irish National Hunt Flat races.

c. **Horses which have won an Academy Hurdle or 3-y-o Junior N.H. Hurdle Race.**

d. **Horses placed 2<sup>nd</sup>, 3<sup>rd</sup>, 4<sup>th</sup> or 5<sup>th</sup> in an Academy Hurdle or 3-y-o Junior N.H. Hurdle Race in either of their last two completed Academy Hurdles or 3-y-o Junior N.H. Hurdle Races.**

e **e.** Horses which have completed less than three times in I.N.H. Flat races run in Ireland.

Note: When protection is equal, horses previously balloted/eliminated from an I.N.H. Flat Race in Ireland, on or subsequent to 180 days prior to the

date of the preliminary ballot will be protected from balloting first, the latest ballot/elimination date at the time of the preliminary ballot stage affording greatest protection. If it is necessary to ballot among horses of equal protection, such ballot will be random. For the purposes of Section (4.5) above, 'pulled up' will be considered a completed run.

#### 4.7 Academy Hurdle Races

**Protection from balloting/elimination will operate in the following order:**

a. **Horses placed 2<sup>nd</sup>, 3<sup>rd</sup>, 4<sup>th</sup> or 5<sup>th</sup> in either of their last two completed runs in Academy Hurdle Races or 3-y-o Junior N.H. Hurdle Races**

b. **Horses which have completed less than three times in Academy Hurdle races run in Ireland.**

**Note: When protection is equal, horses previously balloted/eliminated from Academy Hurdle races in Ireland, on or subsequent to 180 days prior to the date of the preliminary ballot will be protected from balloting first, the latest ballot/elimination date at the time of the preliminary ballot stage affording greatest protection. If it is necessary to ballot among horses of equal protection, such ballot will be random. For the purposes of Section (4.7) above, 'pulled up' will be considered a completed run.**

back on top of him and he ran short of room. K. Callaghan stated that his mount burst blood vessels and stopped quickly. P.M. O'Brien stated that general bunching occurred and his mount clipped a heel and fell. Having viewed the recording of the race and considered the evidence, the Raceday Stewards were satisfied that the incident was caused by Hollow Spark back pedalling quickly and that no further action was warranted.
