Irish Horseracing Regulatory Board Notice

Declaration Of Non-Runners & Reserves

Trainers are requested to note that notifications of a non-runner or declaration of a reserve **can now be done via RAS** or on the dedicated telephone line (045-445645) at the Office of the I.H.R.B. up to 90 minutes before the time of the first race.

If using the Non-Runner/Reserve Telephone Line, the caller will be asked to provide the Trainer's Horse Racing Ireland account number and Trainer's date of birth. All calls are recorded for verification and security purposes. Veterinary certificates, where required, must be sent as usual to the Office of the IHRB within 72 hours. A Trainer failing to lodge a certificate within the time period shall be liable to a fine in accordance with Rule 194(v)(vi).

Trainers wishing to declare a Reserve a runner or a non-runner must also do so **via RAS** or on the same dedicated telephone line number by **10am for meetings, (other than floodlit meetings) during the months of November, December and January** and by 11am for all other meetings including floodlit meetings otherwise the reserve will automatically be withdrawn.

If a rider has not been nominated for a declared reserve the Trainer must do so by the time fixed for declaration of a reserve listed within the paragraph above otherwise the declared reserve will automatically be withdrawn.

Declaration of reserves or of non-runners are no longer accepted at a race meeting.

Updates can be made **via RAS anytime after the publication of Rider Nominations for the meeting up to the specified deadlines.**

The dedicated line number (045 - 445645) is in operation from 9am on weekdays when there is a Race Meeting **and from 8.30am on weekends and Bank Holidays in November, December and January.**

Having taken his previous record into consideration, the Acting Stewards suspended Mr B. Finn for two Point to Point racedays.

STANDARD CONDITIONS

The Racing Calendar Office of Weatherbys Thoroughbred Ltd. receives entries submitted for acceptance as agents for the Racecourse Authority and only upon the terms of the Standard Conditions. Acceptance of entries is subject to the power to refuse to allow entries to be accepted conferred by the Orders and Rules of Racing on the British Horseracing Authority Ltd. Entries are accepted by the Racing Calendar Office, acting as aforesaid, causing the name of the horse in question to be published as being entered for the race in question either in The Racing Calendar, when the race closes more than six days before running, or, for other races, on the British Horseracing Authority Racing Administration Internet site (www.racingadmin.co.uk) and ordinarily in the Sporting Press.

For further details on Standard Conditions, reference should be made to "Standard Conditions" on the Racing Bulletin area of the Racing Administration Internet site (www.racingadmin.co.uk) for the full details.

FRANCE - Owners and trainers of horses trained outside of France are reminded that, to enter any horse in a French race for the first time, they must register their horses in training through their access online at least 8 days before the closing time of entry, with the correct name of the horse, its suffix, sex, year of foaling and pedigree (sire, dam and sire of dam).

This declaration is not considered as an entry. Trainers are to make their entries and other declarations directly online. They must also supply a complete race record of all the performances of the horse(s) entered on the Internet, by fax (33 1 47 61 93 37) or email (fgperf@france-galop.com). The entry will not be valid if these performances are not received by the international department at Racing Operations by the time of the first forfeit, or on the eve of the declaration to run (if entries were made more than a month before the race). When declaring a horse to run, it is the responsibility of the trainer to check the weight carried.

Italy - Owners and trainers of horses trained outside Italy are informed that, the first time they enter any horse to run in Italy, they must include with the entry the correct name, sex, year of foaling, pedigree (sire, dam and sire of dam) and the name of the country where the horse was foaled.

Owners and Trainers are reminded that the foreign race conditions published below are based upon information supplied by the relevant authority. For more detailed race conditions please refer to the relevant authorities racing administration website.

Having viewed a recording of the race and considered the matter, the Raceday Stewards were satisfied that no further action was warranted.

132E Dennison JCB M'dn Hunters S'chase The Raceday Stewards interviewed Mr P.A. King, rider of Grageen, concerning his use of the whip in the closing stages of this race. Evidence was heard from the rider concerned who accepted he was in breach of the whip Regulation and apologised for his actions. Having viewed a recording of the race and considered the evidence, the Raceday Stewards were satisfied that Mr P.A. King was in breach of R.10.3(g)(frequency). Having considered his clean record in this regard, they suspended him for two racedays.

132G Caherty Point-To-Point INH Flat Race Mr D. O'Sullivan, rider of Noble Name, trained by Ms Claire O'Connell, reported to the Clerk of the Scales that his mount was tight for a stride on the point of the bend past the stands.

Mr A.J. Lord, rider of Coded Welder, trained by Paul Mulligan, reported to the Stewards' Secretaries that his mount ducked out.

The Raceday Stewards enquired into an incident on the bend passing the stands involving Coolboy Christy, ridden by Miss P. Elvin, placed second, and Noble Name, ridden by Mr D. O'Sullivan, slipped up, where it appeared interference may have occurred. Evidence was heard from the riders concerned. Mr D. O'Sullivan stated that it was very tight on the point of the bend and was unsure if any contact was made. Miss P. Elvin stated that she maintained her racing line all the way around the bend and never felt contact. Having viewed the recording of the race and considered the evidence, the Raceday Stewards were satisfied that no further action was warranted.

The Stewards authorised the following nomination and substitution of rider at this meeting:

S. Foley replaced N.M. Crosse on Riviera Queen, trained by Mrs John Harrington (Race 2) (intended mount a non runner)

134B Al Basti Equiworld Dubai Orby Stakes S. Foley, rider of Riviera Queen, trained by Mrs John Harrington, reported to the Clerk of the Scales that his mount never let herself down on the ground.

134C Weatherbys Ireland Greenlands Stakes J. Watson, rider of Iberian, trained by Charles Hills (in GB), reported to the Clerk of the Scales that his mount was slowly away.

C. Lee, rider of Lethal Levi (GB), trained by K.R. Burke (in GB), reported to the Clerk of the Scales that his mount hung both ways.

The Raceday Stewards enquired into possible interference inside the final furlong involving Big Gossey, ridden by W.J. Lee, placed third, Lethal Levi (GB), ridden by C. Lee, placed second, and Vespertilio (FR), ridden by D. McMonagle, placed fourth, where it appeared interference occurred. Evidence was heard from the riders concerned. W.J. Lee stated that he committed to a gap at the furlong pole that closed from the right and felt it cost him vital momentum and the race. C. Lee stated that his mount hung both ways despite his best efforts but felt he was clear of Big Gossey and had not caused interference. D. McMonagle stated that his mount had drifted slightly left, was corrected immediately and he also felt he had not caused any interference. Having viewed the recording of the race and considered the evidence, the Raceday Stewards were of the opinion that Big Gossey was never in the gap before it closed and that no alteration to the Judge's placings was necessary. Furthermore, the Raceday Stewards were satisfied that no riding offence had occurred and therefore took no further action.

The Raceday Stewards enquired into an incident inside the final furlong involving Big Gossey, ridden by W.J. Lee, Grand Grey, ridden by J.P. Spencer, and Storm Boy (AUS), ridden by R.L. Moore where it appeared interference occurred. Evidence was heard from the riders concerned. R.L. Moore stated that he was forced to check as he received pressure from his right. W.J. Lee stated that he switched left and did not feel he caused interference. J.P. Spencer stated that his mount drifted left but thought he was clear of the horse inside him. Having viewed the recording of the race and considered the evidence, the Raceday Stewards were satisfied that J.P. Spencer was in breach of Rule 214 in that he had ridden carelessly. Having considered his clean record in this regard, they suspended him for two racedays.

The IHRB Veterinary Officer examined Storm Boy (AUS), trained by A.P. O'Brien, at the request of the Raceday Stewards and reported the animal to be post-race normal.

134D Tulfarris Hotel And Golf Resort H'cap A.J. Slattery, rider of Cloud Seeker (GB), trained by Andrew Slattery, reported to the Clerk of the Scales that it was too tight for him to use his whip in the last fifty yards. The Raceday Stewards reviewed the video footage and were

satisfied that no interference had occurred and took no further action.

R. Whearty, rider of Zoffman, trained by Noel Meade, reported to the Clerk of the Scales that he had to check at the furlong pole.

W.M. Lordan, rider of Molto Amichi, trained by Eoin Griffin, reported to the Clerk of the Scales that his mount was difficult in the stalls.

The IHRB Veterinary Officer examined Aeronautic, trained by Joseph Patrick O'Brien, at the request of the Raceday Stewards and reported the animal to be post-race normal.

The IHRB Veterinary Officer examined Molto Amichi, trained by Eoin Griffin, at the request of the Raceday Stewards and reported the animal to have grazed the outside of his left fore canon but was otherwise found to be post-race normal.

134E Tattersalls Irish 2,000 Guineas G.M. Ryan, rider of Comanche Brave, trained by Donnacha Aidan O'Brien, reported to the Clerk of the Scales that his mount received a little bump at the two furlong pole.

The IHRB Veterinary Officer examined Officer, trained by A.P. O'Brien, at the request of the Raceday Stewards and reported the animal to be post-race normal.

The Raceday Stewards enquired into an incident at the two furlong pole involving Comanche Brave, ridden by G.M. Ryan, Field Of Gold, ridden by C.T. Keane and Officer, ridden by R.L. Moore where it appeared interference occurred. Evidence was heard from the riders concerned. G.M. Ryan stated that as Field Of Gold passed him he drifted slightly right which caused his mount to lean on Officer. R.L. Moore stated that he felt slight pressure from his left. C.T. Keane stated that as he passed the horses on his inside his mount leaned slightly right. Having viewed the recording of the race and considered the evidence, the Raceday Stewards took no further action.

134F QuinnBet Emerald Mile H'cap The Raceday Stewards enquired into an incident inside the final two furlongs involving Coeur D'or, ridden by C.D. Hayes, Presence, ridden by K.G. Kennedy and No More Porter, ridden by D.P. McDonogh where it appeared interference may have occurred. Evidence was heard from the riders concerned. K.G. Kennedy stated that he felt pressure from both sides. D.P. McDonogh stated that he felt he kept a straight line and did not cause interference. C.D. Hayes stated that he felt there was sufficient room to manoeuvre out into a gap. Having viewed the recording of the race and considered the evidence, the Raceday Stewards found C.D. Hayes was in breach of Rule 214 in that he had ridden carelessly. Having considered his clean record in this regard, the Raceday Stewards suspended him for two racedays. The Raceday Stewards also reminded K.G. Kennedy to be more accurate with his evidence in future enquiries.

R.P. Cleary, rider of Enchanted Garden, trained by Anthony Mullins, reported to the Clerk of the Scales that his mount hung right from the furlong pole.

134G Revamp Restoration And Conservation H'cap Prior to the start of this race the Clerk of the course changed the going to Good, Good to Yielding in places.

The IHRB Veterinary Officer examined Jagged Edge, trained by D.K. Weld, at the request of the Raceday Stewards and reported the animal to be post-race normal.

134J QuinnBet H'cap J. Kearney, rider of Plume Noire, trained by Gerard Keane, reported to the Clerk of the Scales that his mount stumbled leaving the stalls.

S. Foley, rider of Marakesh (GB), trained by Henry de Bromhead, reported to the Clerk of the Scales that his mount struggled from the halfway mark.


