Of which the winner will receive €500,000, (Penalty Value: €495,000), the second €200,000, the third €100,000, the fourth €60,000, the fifth €40,000, the sixth €30,000, the seventh €25,000, the eighth €20,000, the ninth €15,000 and the tenth €10,000.

For two yrs old only which had been catalogued in the 2024 Goffs Orby Sale (Book 1 or Book 2) and have been declared by Goffs Bloodstock Sales Ltd. as eligible to enter and run in accordance with the relevant Conditions of Sale. Horses which do not have a registered name and have not been recorded as Racing Active with a Licensed Trainer by Wednesday 23rd July, 2025 (or if entered from a Foreign Racing Authority named and recorded with a Licensed Trainer) will be automatically struck out of this race. (Please note for un-named horses trained in Ireland which were foaled in Britain or Ireland an acceptable naming application should be made to HRI by Thursday, 17th July, 2025 and for all other un-named horses (horses foaled outside of Ireland & GB), naming forms should be submitted earlier as the naming process will take longer).

€2,000 to enter (plus €15.00 bookage fee),

€2,000 extra (plus €52.50 bookage fee), if forfeit not declared by 23rd July,

€1,000 extra (plus €52.50 bookage fee) if forfeit not declared by 23rd September,

Weights:9st 5lb Fillies allowed.....5lb

In order to facilitate those people wishing to make entries for this race, the Stewards of the I.H.R.B., using their powers under Rule 22, have suspended the appropriate paragraphs of the following Rules, Rule 121, 122 and 194(ii)(c). HRI Directive 10 is suspended for the purpose of this race.

Should it be necessary to reduce the number of declared runners to the maximum runners, or to such lesser number as may be required the following procedures shall be applied for the elimination and balloting of horses:

(i) Runners will first be reduced by balloting from among those horses that have not run.

(ii) In the event of (i) not achieving the recommended limit runners will then be reduced by balloting from among those horses that, in the opinion of the Handicappers, have the lowest adjusted ratings (having regard to the applicable sex allowance). International performances will be taken into account.

The latest date for calculation of ratings is 10 a.m. on Tuesday, 23rd September, 2025.

All entry & forfeit fees (€5,000) will be refunded to the owners of those horses that are eliminated from this race.

Nominators who do not have a current racing account should include cheque for €2,015.00 for each nomination.
