For two yrs old only which had been catalogued in the 2023 Goffs Orby Sale (Book 1 or Book 2) and have been declared by Goffs Bloodstock Sales Ltd. as being eligible to enter and run in accordance with the relevant Conditions of Sale. Horses which do not have a registered name and are not Returned In Training with a Licensed Trainer by Wednesday 24th July, 2024 will be automatically struck out of this race. (Please note for Irish and British bred horses, trained in Ireland, an acceptable naming application should be made to HRI by Thursday, 18th July, 2024 at the very latest. For all other foreign bred horses, trained in Ireland, naming applications will take longer to process)

Seven Furlongs

€2,000 to enter (plus €15.00 bookage fee),

€2,000 extra (plus €52.50 bookage fee), if forfeit not declared by 24th July,

€1,000 extra (plus €52.50 bookage fee) if forfeit not declared by 24th September,

Weights:9st 5lb Fillies allowed.....5lb

In order to facilitate those people wishing to make entries for this race, the Stewards of the I.H.R.B., using their powers under Rule 22, have suspended the appropriate paragraphs of the following Rules, Rule 103 (i), 106, 121, 122 and 194(ii)(c).

HRI Directive 10 is suspended for the purpose of this race.

Should it be necessary to reduce the declared runners to the maximum runners, or to such lesser number as may be required the following procedures shall be applied for the elimination and balloting of horses:

(i) Runners will be reduced by balloting from among those horses that have not run.

(ii) In the event of (i) not achieving the recommended limit runners will then be reduced by balloting from among those horses that, in the opinion of the Handicappers, have the lowest adjusted ratings (having regard to the applicable sex allowance). International performances will be taken into account. The latest date for calculation of ratings is 10 a.m. on Tuesday, 24th September, 2024.

All entry & forfeit fees (€5,000) will be refunded to the owners of those horses that are eliminated from this race.

Horses entered in this race will automatically be entered in the Goffs 500 of €500,000 over 6 furlongs on the same day.

Horses which remain in this race after the final forfeit stage on Tuesday, September 24th can then choose to declare for this race or the Goffs 500 by 10 a.m. on Thursday, September 26th.

Nominators who do not have a current racing account should include cheque for €2,015.00 for each nomination.
