Changes to Regulation 16 - Procedure For Mounting In Parade Ring

On the 17 July 2025, the Directors of the IHRB approved the following changes to Regulation 16 (page 198) which will become effective on 25 July 2025:

PROCEDURE FOR MOUNTING IN PARADE RING

The following procedures shall be adopted at all Racecourses.

Upon the official signal to mount, Riders shall be present in the parade ring and Trainers must ensure that the Rider mount the Horse on the walk without undue delay, ensuring the Horse continues to proceed around the parade ring.

Horses shall not cross the parade ring except with the permission of an IHRB Official.

Trainers are responsible for all staff in ensuring they comply with all Rules and Procedures.

Any Trainer or Rider who fails to comply, or whose conduct contributes to a failure to comply, shall be liable to sanction and such fine as deemed necessary.

The Curragh Racecourse – Regulatory Notice

The Irish Horseracing Regulatory Board (IHRB) today confirms that its review into the circumstances arising during the running of the Paddy Power Pretty Polly Stakes at the Curragh on 28 June 2025 has now concluded. Following that race, the Raceday Stewards conducted an enquiry under Rule 13(i) into the presence of a photographer who was positioned within five metres of the inside running rail approximately 140 yards from the winning post and who appeared to catch the eye of Whirl, ridden by Ryan Moore, possibly causing the horse to jink slightly.

Evidence was heard on the day from Mr Brian Kavanagh, Chief Executive of the Curragh Racecourse, who indicated he was unaware of the photographer's identity at the time but accepted that she should not have been in that location. The matter was referred, without prejudice, to the IHRB to allow the racecourse to conduct a full internal investigation.

As part of the IHRB's review, the Chief Executive of the Curragh Racecourse provided a detailed and prompt response, confirming that the photographer in question was a freelance operator accredited in advance of the fixture but who had not adhered to issued guidelines regarding track access.

The Curragh Racecourse has acknowledged the seriousness of the breach of protocol, despite no impact on the outcome of the race, and has proactively proposed and committed to enhanced procedures to prevent any recurrence including a requirement for photographers to sign a form attesting that they have read and will comply with the guidelines and that a member of Curragh Racecourse staff will be positioned in the vicinity of the final two furlongs to ensure no repeat of this type of incident arises.

Having carefully considered all evidence and the Curragh Racecourse's thorough and constructive engagement with the review process, the IHRB has determined that no further regulatory action is required in respect of these matters.

Referral

The Referrals Committee, with Mr Martin P O'Donnell as chairman, convened at the Offices of the Irish Horseracing Regulatory Board on Tuesday, 01 July 2025 to consider the referral of Mr D M Fitzgerald (Rider) following the Joe Quinn Transport Longford Handicap Hurdle on 01 June 2025.

On the day, the Raceday Stewards enquired into the first approach to the starter involving Loup De Tallane (FR), ridden by A P Kelly, Blue Reed (FR), ridden by C P Millar, Cosmo Renfro, ridden by K E Buckley, Simpletwistoffaith, ridden by D J O'Keeffe, Kinbara Hills, ridden by S W Flanagan, Ballykinlar, ridden by A McCurtin, Our Uncle Jack, ridden by Mr D M Fitzgerald, Johanna's Jean, ridden by C Stone-Walsh, Silent Dawn, ridden by D Meyler, Getaway Master, ridden by J J Slevin, Give Him A Chance, ridden by T Power Roche, Sydney Cruiser, ridden by T P Harney, Give Her Hollie, ridden by J C Gainford and The Anniversary Man, ridden by Niall Moore, where it appeared all horses broke into a trot or canter before the flag was raised. As Mr Fitzgerald did not return following the deliberations the Raceday Stewards referred his conduct to a Senior Racing Official for further investigation.

At the referral hearing, a submission from Mr Fitzgerald was considered.

In his submission, Mr Fitzgerald outlined that he had attended the enquiry initially and mistakenly thought the matter had concluded when all Riders were asked to leave the Stewards Room. Mr Fitzgerald explained that he then went to the stable yard to assist his father who was travelling with Our Uncle Jack as the horse was becoming restless and was unaware that he was required following deliberations.

Having considered all submissions, the Referrals Committee took no further action other than to notify the rider of his obligations to return to the Stewards Room following the deliberations of the Raceday Stewards.

The case was presented by Ms Christine Traynor, BL, IHRB Head of Racing Regulation and Integrity.

Referral

The Referrals Committee, with Mr Raymond J McSharry as chairman, convened at the Offices of the Irish Horseracing Regulatory Board on Tuesday, 01 July 2025 to consider the referral of Ambrose McCurtin (Rider) following the Joe Quinn Transport Longford Handicap Hurdle at Kilbeggan on 01 June 2025.

On the day, the Raceday Stewards enquired into the first approach to the starter involving Loup De Tallane (FR), ridden by A P Kelly, Blue Reed (FR), ridden by C P Millar, Cosmo Renfro, ridden by K E Buckley, Simpletwistoffaith, ridden by D J O'Keeffe, Kinbara Hills, ridden by

S W Flanagan, Ballykinlar, ridden by A McCurtin, Our Uncle Jack, ridden by Mr D M Fitzgerald, Johanna'sjean, ridden by C. Stone-Walsh, Silent Dawn, ridden by D Meyler, Getaway Master, ridden by J J Slevin, Give Him A Chance, ridden by T Power Roche, Sydney Cruiser, ridden by T P Harney, Give Her Hollie, ridden by J C Gainford and Theanniversary Man, ridden by Niall Moore, where it appeared all horses broke into a trot or canter before the flag was raised. As Mr McCurtin had left the racetrack prior to the enquiry the Raceday Stewards referred the matter to a Senior Racing Official for further investigation.

At the referral hearing, a submission from Mr McCurtin was considered.

In his submission, Mr McCurtin apologised for not attending the enquiry and stated that it was down to a honest misunderstanding on his behalf.

Having considered all submissions, the Referrals Committee took no further action other than to remind Mr McCurtin of his obligations under Rule 229(v) leaving the racecourse prior to 10 minutes after the winner alright has been announced.

The case was presented by Ms Christine Traynor BL, IHRB Head of Racing Regulation and Integrity.

Referral

The Referrals Committee, Mr Martin P O'Donnell (Chairman), Mr Raymond J McSharry and Mr Jack Rearden convened at the Offices of the Irish Horseracing Regulatory Board on Tuesday, 01 July 2025 to consider the referral of Mr Finn Brickley (Rider) following the the Bulmers Handicap Hurdle in Clonmel on 06 June 2025.

On the day, the Raceday Stewards, wished to enquire into the riders first approach to the Starter. However, it appeared Mr Brickley, rider of Fils d'Oudairies, had left the racecourse prior to 10 minutes after the winner alright had been announced as required under Rule 229(v). The matter was referred on to the Referrals Committee for further investigation

At the Referrals Committee hearing, evidence was heard from Mr Brickley.

In his evidence, Mr Brickley stated he believed he had waited 10 minutes after the winner alright had been announced as he could recall talking to a member of Gordon Elliott's staff outside the weighroom. Mr Brickley said that he then left the track to attend a family funeral before becoming aware that he was required by the Raceday Stewards. In relation to the first approach to the Starter, Mr Brickley said that it was his intention to be third or fourth and not make the running in the race but his mount was an experienced horse who knew his job and had started to move forward as horses approached around him. Mr Brickley added that he did not intend to cause a false start but that he had struggled to restrain his mount who can be keen at times.

Having considered Mr Brickley's evidence, the Referrals Committee took no further action.

The case was presented by Mr Andrew Ring, IHRB Stipendiary Steward, instructed by Ms Christine Traynor, BL, IHRB Head of Racing Regulation and Integrity.

Appeal

The Appeals Body, Mr Martin P O'Donnell (Chairman), Mr Raymond J McSharry and Mr Jack Reardon convened at the Offices of the Irish Horseracing Regulatory Board on Tuesday, 01 July 2025 to consider the appeal of Ms Michelle Shannon (Owner) against the decision of the Raceday Stewards at Down Royal, 20 June 2025.

On the day, following the running of the Laura Nicholas Handicap, the Raceday Stewards enquired into possible interference at the top of the hill and rounding the home bend involving Purring Along, ridden by R P Whelan, placed first, Saxon Kingdom, ridden by G M Ryan, placed third, and Bamako, ridden by W J Lee, placed second, where it appeared that interference may have occurred. Having viewed the recording of the race and considered the evidence, the Raceday Stewards were of the opinion that Purring Along had caused interference to Bamako and as a result of this interference had improved its finishing position. As a consequence, the Raceday Stewards reversed the placings and demoted Purring Along from first place to second place.

The grounds of the appeal lodged by Ms Shannon were that Purring Along did not improve her finishing position as a result of causing interference to Bamako and was the winner on merit on the day.

At the appeal hearing, evidence was heard from Mr Whelan, rider of Purring Along and Mr Lee, rider of Bamako. The Appeals Body also watched a recording of the race.

In his evidence Mr Whelan stated that he received pressure from his inside and was pushed outwards. Mr Whelan did not dispute that he had caused interference but believed that the interference did not improve his finishing position and believed he was riding the best horse on the day.

In his evidence Mr Lee stated that he believed his mount received contact on three occasions from his inside. Mr Lee believed this had halted his momentum and therefore his mount had lost significant ground and that took a lot out of his horse on the day.

Having considered all the evidence presented, the Appeals Body were not satisfied that Bamako was disadvantaged enough to reverse the positions of the race and therefore the appeal was allowed and the placings amended accordingly. The results now reads as follows:-

STANDARD CONDITIONS

The Racing Calendar Office of Weatherbys Thoroughbred Ltd. receives entries submitted for acceptance as agents for the Racecourse Authority and only upon the terms of the Standard Conditions. Acceptance of entries is subject to the power to refuse to allow entries to be accepted conferred by the Orders and Rules of Racing on the British Horseracing Authority Ltd. Entries are accepted by the Racing Calendar Office, acting as aforesaid, causing the name of the horse in question to be published as being entered for the race in question either in The Racing Calendar, when the race closes more than six days before running, or, for other races, on the British Horseracing Authority Racing Administration Internet site (www.racingadmin.co.uk) and ordinarily in the Sporting Press.

FRANCE - Owners and trainers of horses trained outside of France are reminded that, to enter any horse in a French race for the first time, they must register their horses in training through their access online at least 8 days before the closing time of entry, with the correct name of the horse, its suffix, sex, year of foaling and pedigree (sire, dam and sire of dam).

This declaration is not considered as an entry. Trainers are to make their entries and other declarations directly online. They must also supply a complete race record of all the performances of the horse(s) entered on the Internet, by fax (33 1 47 61 93 37) or email (fgperf@france-galop.com). The entry will not be valid if these performances are not received by the international department at Racing Operations by the time of the first forfeit, or on the eve of the declaration to run (if entries were made more than a month before the race). When declaring a horse to run, it is the responsibility of the trainer to check the weight carried.

Italy - Owners and trainers of horses trained outside Italy are informed that, the first time they enter any horse to run in Italy, they must include with the entry the correct name, sex, year of foaling, pedigree (sire, dam and sire of dam) and the name of the country where the horse was foaled.

Coen stated that he had to check. K.J. Leonard stated that when passing tired horses, he moved out to switch off heels. Having viewed the recording of the race and considered the evidence, the Raceday Stewards were satisfied that K.J. Leonard, was in breach of Rule 214 in that he had ridden carelessly.
