Important Notice – Hunters Certificates

Owners and Handlers of horses who wish to run at Mid Antrim (H) on Saturday 4th October and Westmeath (F) on Sunday 5th October should ensure that Hunters Certificates are lodged at the Office of the IHRB, The Curragh, Co. Kildare, R56 Y668 for registration **no later than close of business on Monday 15th September.**

Owners and Handlers of horses who wish to run at Route (H) on Saturday 11th October and Galway Blazers (F) on Sunday 12th October should ensure that Hunters Certificates are lodged at the Office of the IHRB, The Curragh, Co. Kildare, R56 Y668 for registration **no later than close of business on Monday 22nd September.**

Changes to Regulation 16 - Procedure For Mounting In Parade Ring

On the 17 July 2025, the Directors of the IHRB approved the following changes to Regulation 16 (page 198) which will become effective on 25 July 2025:

PROCEDURE FOR MOUNTING IN PARADE RING

The following procedures shall be adopted at all Racecourses.

Upon the official signal to mount, Riders shall be present in the parade ring and Trainers must ensure that the Rider mount the Horse on the walk without undue delay, ensuring the Horse continues to proceed around the parade ring. Horses shall not cross the parade ring except with the permission of an IHRB Official.

Trainers are responsible for all staff in ensuring they comply with all Rules and Procedures.

Any Trainer or Rider who fails to comply, or whose conduct contributes to a failure to comply, shall be liable to sanction and such fine as deemed necessary.

Horse Racing Ireland Directives:

The Directors of Horse Racing Ireland have approved the following modifications to HRI Directives 4 & 10 to come into effect in October 2025.

HRI DIRECTIVE 4

Race Conditions for I.N.H. Flat Races:

3. Qualification

A horse shall not be qualified to start for an I.N.H. flat race if:

- It has run in a Flat race or Steeplechase.
- It has run in a Hurdle race as a three year old (excluding Academy Hurdles or 3-y-o Junior N.H. Hurdle Races)
- It has run in more than two Hurdle races.
- It has won a Hurdle race (excluding Academy Hurdles or 3-y-o Junior N.H. Hurdle Races)

HRI DIRECTIVE 10

Elimination and Balloting out of Horses:

4. In Weight For Age National Hunt Races (excluding Pattern/Listed Races)

4.1 Steeplechases (other than Beginners Steeplechases)

Protection from balloting will operate in the following order:

- Horses which have won a Grade 1, 2 or 3 Weight For Age National Hunt race run under the Rules of any Recognised Turf Authority.
- Horses which have won a Steeplechase run under the Rules of any Recognised Turf Authority and which do not have an official Steeplechase rating in Ireland.
- Horses which have won a Steeplechase run under the Rules of any Recognised Turf Authority and which have an official Steeplechase rating in Ireland, the highest rating affording the greatest protection.
- Horses which have an official Steeplechase rating in Ireland of 115 or more, the highest rating affording the greatest protection.
- Horses which have won a Hurdle race, an I.N.H. Flat race, or a National Hunt Flat race run under Rules of any Recognised Turf Authority and which were placed 2nd, 3rd, 4th or 5th in either of their last two completed Steeplechases run in Ireland.
- Horses which have won a Hurdle race (excluding Academy Hurdles or 3-y-o Junior N.H. Hurdle Races) run under the Rules of any Recognised Turf Authority and which have completed in less than three Steeplechases run in Ireland.
- Horses which have won an I.N.H. Flat race or a National Hunt Flat race under the Rules of any Recognised Turf Authority and which have completed in less than three Steeplechases run in Ireland.
- Horses which have won an Academy Hurdle or 3-y-o Junior N.H. Hurdle Race and which have completed in less than three Steeplechases run in Ireland.
- Horses placed 2nd 3rd, 4th, or 5th in either of their last two completed Steeplechases run in Ireland.
- Horses which have completed in three or more Steeplechases run in Ireland and to which the handicapper is not prepared to allocate an official

Steeplechase rating in Ireland.

- j **k.** Horses which have completed less than three times in steeplechases run in Ireland.
- k **l.** Horses which have the highest official Steeplechase rating in Ireland below 115 at time of entry, the highest rating affording the greatest protection.

Note: When protection is equal, horses previously balloted/eliminated from a Steeplechase run under I.N.H.S. Rules, on or subsequent to 180 days prior to the date of the preliminary ballot will be protected from balloting first, the latest ballot/elimination date at the time of the preliminary ballot stage affording greatest protection. If it is necessary to ballot among horses of equal protection, such ballot will be random. For the purposes of Section (4.1) above, 'pulled up' will be considered a completed run.

4.2 Beginners Steeplechases

Protection from balloting will operate in the following order:

- a. Horses which have won a Grade 1, 2 or 3 Weight for Age National Hunt race run under the Rules of any Recognised Turf Authority and which have completed in less than three Steeplechases run in Ireland.
- b. Horses which have an official Steeplechase rating in Ireland of 115 or more, the highest rating affording the greatest protection.
- c. Horses placed 2nd, 3rd, 4th or 5th in either of their last two completed weight-for-age Steeplechases run in Ireland.
- d. Horses which have won a Hurdle race **(excluding Academy Hurdles or 3-y-o Junior N.H. Hurdle Races)** run under the Rules of any Recognised Turf Authority and which have completed in less than three Steeplechases run in Ireland.
- e. Horses which have won a I.N.H. Flat race or a National Hunt Flat race under the Rules of any Recognised Turf Authority and which have completed in less than three Steeplechases run in Ireland.
- f. **Horses which have won an Academy Hurdle or 3-y-o Junior N.H. Hurdle Race and which have completed in less than three Steeplechases run in Ireland.**
- f **g.** Horses which have completed in two, three or four Steeplechases run in Ireland and to which the handicapper is not prepared to allocate an official Steeplechase rating in Ireland.
- g **h.** Horses which have completed less than three times in Steeplechases run in Ireland.

- h **i.** Horses which have the highest official Steeplechase rating in Ireland below 115 at time of entry, the highest rating affording the greatest protection.
- i **j.** Horses which have completed five or more times in Steeplechases run in Ireland and do not have an official Steeplechase rating in Ireland.

Note: When protection is equal, horses previously balloted/eliminated from a Steeplechase run under I.N.H.S. Rules, on or subsequent to 180 days prior to the date of the preliminary ballot will be protected from balloting first, the latest ballot/elimination date at the time of the preliminary ballot stage affording greatest protection. If it is necessary to ballot among horses of equal protection, such ballot will be random. For the purposes of Section (4.2) above, 'pulled up' will be considered a completed run.

4.3 Hurdles (other than Maiden Hurdles)

Protection from balloting will operate in the following order

- a. Horses which have won a Grade 1, 2 or 3 Weight For Age National Hunt race or a Group 1, 2 or 3 Flat race run under the Rules of any Recognised Turf Authority.
- b. Horses which have won a Hurdle race **(excluding Academy Hurdles or 3-y-o Junior N.H. Hurdle Races)** run under the Rules of any Recognised Turf Authority and which do not have an official Hurdle rating in Ireland.
- c. Horses which have won a Hurdle race run under the Rules of any Recognised Turf Authority and which have an official Hurdle rating in Ireland, the highest rating affording the greatest protection.
- d. Horses which have won a **an Academy Hurdle, a 3-y-o Junior N.H. Hurdle Race, an I.N.H. Flat race, or a National Hunt Flat race or a Flat race** run under the Rules of any Recognised Turf Authority and which were placed 2nd, 3rd, 4th or 5th in either of their last two completed hurdle races run in Ireland.
- e. Horses which have won an I.N.H. Flat race or a National Hunt Flat race run under the Rules of any Recognised Turf Authority and which have completed in less than three hurdle races run in Ireland.
- f. **Horses which have won an Academy Hurdle or 3-y-o Junior N.H. Hurdle Race which do not have an official Hurdle rating and**

which have completed in less than three Hurdle races run in Ireland.

- f **g.** Horses which have an official Hurdle rating in Ireland of 105 or more, the highest rating affording the greatest protection.
- g **h.** Horses placed 2nd, 3rd, 4th, or 5th in either of their last two completed Hurdle races run in Ireland.
- h **i.** Horses which have won a Flat race run under the Rules of any Recognised Turf Authority on or subsequent to January 1st of the year previous to the current year and which have completed in less than three hurdle races run in Ireland.
- i **j.** Horses which have won a Flat race run under the Rules of any Recognised Turf Authority and which have completed in less than three Hurdle races run in Ireland.
- j **k.** Horses which have completed in three or more Hurdle races run in Ireland and to which the handicapper is not prepared to allocate an official Hurdle rating in Ireland.
- k **l.** Horses which have completed less than three times in Hurdle races run in Ireland.
- l **m.** Horses which have the highest official Hurdle rating in Ireland below 105 at time of entry, the highest racing affording the greatest protection

Note: When protection is equal, horses previously balloted/eliminated from a Hurdle Race run under I.N.H.S. Rules, on or subsequent to 180 days prior to the date of the preliminary ballot will be protected from balloting first, the latest ballot/elimination date at the time of the preliminary ballot stage affording greatest protection. If it is necessary to ballot among horses of equal protection, such ballot will be random. For the purposes of Section (4.3) above 'pulled up' will be considered a completed run.

4.4 Maiden Hurdles

Protection from balloting will operate in the following order:

- a. Horses which have won a Grade 1, 2 or 3 Weight for Age National Hunt race or a Group 1, 2 or 3 Flat race run under the Rules of any Recognised Turf Authority and which have completed in less than three Hurdle races run in Ireland.
- b. Horses which have an official Hurdle rating in Ireland of 115 or more at the time of entry (105 from 1st May to 30th September), the highest rating affording the greatest protection.

- c. Horses placed 2nd, 3rd, 4th or 5th in either of their last two completed weight-for-age Hurdle races run in Ireland (excluding Academy Hurdles or 3-y-o Junior N.H. Hurdle Races).
- d. Horses which have won an I.N.H. Flat race or a National Hunt Flat race run under the Rules of any Recognised Turf Authority and which have completed in less than three Hurdle races run in Ireland.
- e. Horses which have won an Academy Hurdle or 3-y-o Junior N.H. Hurdle Race and which have completed in less than three Hurdle races run in Ireland.
- e f. Horses which have won a Flat race run under the Rules of any Recognised Turf Authority and which have completed in less than three Hurdle races run in Ireland.
- g. Horses placed 2nd, 3rd, 4th or 5th in an Academy Hurdle or 3-y-o Junior N.H. Hurdle Race in either of their last two completed Academy Hurdles or 3-y-o Junior N.H. Hurdle Races.
- g h. Horses which have completed in three, four or five Hurdle races run in Ireland and to which the handicapper is not prepared to allocate an official Hurdle rating in Ireland.
- h i. Horses which have completed less than three times in Hurdle races run in Ireland.
- i j. Horses which have the highest official Hurdle rating in Ireland below 115 at time of entry (105 from 1st May to 30th September), the highest rating affording the greatest protection.
- j k. Horses which have completed six or more times in Hurdle races run in Ireland and do not have an official Hurdle rating in Ireland.

Note: When protection is equal, horses previously balloted/eliminated from a Hurdle race run under I.N.H.S. Rules, on or subsequent to 180 days prior to the date of the preliminary ballot will be protected from balloting first, the latest ballot/elimination date at the time of the preliminary ballot stage affording greatest protection. If it is necessary to ballot among horses of equal protection, such ballot will be random. For the purposes of Section (4.4) above, 'pulled up' will be considered a completed run.

4.5 I.N.H. Flat Races

Protection from balloting/elimination will operate in the following order:

- a. Horses which have won an I.N.H. Flat race or a National Hunt Flat race run under the Rules of any recognised Turf Authority.

- b. Horses placed 2nd, 3rd, 4th or 5th in either of their last two completed runs in Irish National Hunt Flat races.
- c. Horses which have won an Academy Hurdle or 3-y-o Junior N.H. Hurdle Race.
- d. Horses placed 2nd, 3rd, 4th or 5th in an Academy Hurdle or 3-y-o Junior N.H. Hurdle Race in either of their last two completed Academy Hurdles or 3-y-o Junior N.H. Hurdle Races.
- e e. Horses which have completed less than three times in I.N.H. Flat races run in Ireland.

Note: When protection is equal, horses previously balloted/eliminated from an I.N.H. Flat Race in Ireland, on or subsequent to 180 days prior to the date of the preliminary ballot will be protected from balloting first, the latest ballot/elimination date at the time of the preliminary ballot stage affording greatest protection. If it is necessary to ballot among horses of equal protection, such ballot will be random. For the purposes of Section (4.5) above, 'pulled up' will be considered a completed run.

4.7 Academy Hurdle Races

Protection from balloting/elimination will operate in the following order:

- a. Horses placed 2nd, 3rd, 4th or 5th in either of their last two completed runs in Academy Hurdle Races or 3-y-o Junior N.H. Hurdle Races
- b. Horses which have completed less than three times in Academy Hurdle races run in Ireland.

Note: When protection is equal, horses previously balloted/eliminated from Academy Hurdle races in Ireland, on or subsequent to 180 days prior to the date of the preliminary ballot will be protected from balloting first, the latest ballot/elimination date at the time of the preliminary ballot stage affording greatest protection. If it is necessary to ballot among horses of equal protection, such ballot will be random. For the purposes of Section (4.7) above, 'pulled up' will be considered a completed run.

Evidence was heard from the riders concerned. K.M. Donoghue, D.J. Gilligan and J.W. Kennedy all said they kept a straight line. P. Townend said his horse was going backwards but he tried to keep a straight line. R.J. Condon said there initially was a gap but it became congested and he had to take back. He added that he did not have the horse to fill the gap. Having viewed the recording of the race and considered the evidence, the Raceday Stewards took no further action.

The IHRB Veterinary Officer examined Night Moon (GER), trained by W.P. Mullins, at the request of the Raceday Stewards and reported the animal to be post race normal.

219B BoyleSports H'cap H'dle The Raceday Stewards enquired into an incident on the run to the second last involving Fascile Mode, ridden

by J. Coen, placed second, and Winning Smut, ridden by J.W. Kennedy, placed first, where it appeared interference may have occurred. Evidence was heard from the riders concerned. J. Coen said he was riding to meet the rail when he realised J.W. Kennedy was on his inside so he left room. J.W. Kennedy said he received minor interference. Having viewed the recording of the race and considered the evidence, the Raceday Stewards took no further action.

The Raceday Stewards enquired into the start of this race where it appeared Dream On Baby, ridden by D. Meyler, was left a distance behind and did not participate in the race. Evidence was heard from Mr J.R. Banahan, IHRB Starter, and D. Meyler, rider of Dream on Baby. Mr. Banahan said he had instructed all riders to go back to the hurdle behind them after their initial approach to him. He added not all riders went back as instructed. However, he accepted D. Meyler had gone back and was aware that he was behind and heard him calling out but thought he was closer to the field. D. Meyler said he was the only rider to fully comply with the Starter's instructions and the Starter started the race when he was too far back and all chance was gone. Having viewed the recording of the start and considered the evidence, the Raceday Stewards using their powers under Rule 209(v) (Starter error) declared Dream On Baby a non runner. Having decided that this was a case of starter error, the Raceday Stewards referred this finding and the issues of compliance of all riders (except D. Meyler) with the Starter's instructions to a Senior Racing Official for further investigation.

D. Meyler, rider of Dream On Baby, trained by Emmet Mullins, reported to the Clerk of the Scales that he was the only one to do what he was told at the start and he was left 10 lengths as a consequence.

P. Townend, rider of Maughreen, trained by W.P. Mullins, reported to the Clerk of the Scales that his mount completed the race but was injured after the line.

219C BoyleSports Galway Tribes H'cap H'dle The Raceday Stewards enquired into an incident on the home bend involving Putapoundinthejar, ridden by K.C. Sexton, unplaced, Autumn Twist, ridden by D. King, unplaced, and Run For Harry, ridden by P.M. O'Brien, unplaced, where it appeared interference may have occurred. Evidence was heard from the riders concerned. K.C. Sexton and D. King both said it was tight on the bend. P.M. O'Brien said he received pressure from his left. Having viewed the recording of the race and considered the evidence, the Raceday Stewards took no further action other than to advise K.C. Sexton to be more aware when horses are slowing up in front of him.

219D Whiskey Refrigeration Irish European Breeders Fund M'dn The Raceday Stewards reviewed an incident in the straight involving Adel (GER), ridden by R.P. Whelan, where it appeared he had to check. Having viewed the recording of the race and considered the matter, the Raceday Stewards were satisfied that no further action was warranted.

At the request of the Raceday Stewards, R.P. Whelan, rider of Adel (GER), trained by M.D. O'Callaghan, reported to the Stewards' Secretaries that his mount ran green early and had to take a precautionary check in the straight.

At the request of the Raceday Stewards, J.A. Heffernan, rider of Monvoe, trained by R.P. Cody, reported to the Stewards' Secretaries that his mount ran very freely.

219E Bathshack M'dn N.M. Crosse, rider of Little Miss P, trained by W. McCreery, reported to the Clerk of the Scales that his mount leaned left throughout.

219F Ardilaun Hotel H'cap The Raceday Stewards enquired into an incident on the home bend involving Tai Tam Bay, ridden by C.D. Hayes, unplaced, Comfort Line, ridden by Adam Caffrey, placed third, and Reidh, ridden by O.J. Orr where it appeared Tai Tam Bay ran short of room. Evidence was heard from the riders concerned. C.D. Hayes said he ran short of room turning in. Adam Caffrey said there was enough room for a horse on his inside and was aware of the chance of a horse being there. O.J. Orr felt he kept his line and had plenty room. Having viewed the recording of the race and considered the evidence, the Raceday Stewards found Adam Caffrey was in breach of Rule 214 in that he had ridden carelessly. Having considered his record in this regard, the Raceday Stewards suspended him for four racedays.

J. Kearney, rider of Goldrush Kid, trained by Patrick Magee, reported to the Clerk of the Scales that his mount leaned left under pressure.

C.D. Hayes, rider of Tai Tam Bay, trained by Eddie & Patrick Harty, reported to the Clerk of the Scales that his mount was interfered with turning in.

K.G. Kennedy, rider of Lucky Out, trained by Miss Tara Lee Cogan, reported to the Clerk of the Scales that his mount was slowly away and had no luck in the straight.

219G McDonogh Capital Investments H'cap The Raceday Stewards enquired into an incident on the home bend involving Impero, ridden by G.F. Carroll, unplaced, and Thatwilldoso, ridden by R.P. Cleary where it appeared interference may have occurred. Evidence was heard from the riders concerned. G.F. Carroll said he did not feel much interference. R.P. Cleary said went for a gap on his outer and thought he was clear of Impero. Having viewed the recording of the race and considered the evidence, the Raceday Stewards took no further action other than to advise R.P. Cleary to be more aware in future when making a manoeuvre.

J.M. Sheridan, rider of Luker's Tipple, trained by Andrew Kinirons, reported to the Clerk of the Scales that his mount was struck into about five furlongs from home. The Raceday Stewards reviewed the matter and were satisfied that no further action was warranted.

D.P. McDonogh, rider of First Ascent, trained by Matthew J. Smith, reported to the Clerk of the Scales that his mount stumbled out of stalls.

Adam Caffrey, rider of Catena Zapata, trained by Ian Patrick Donoghue, reported to the Clerk of the Scales that his mount ran very freely.

K.G. Kennedy, rider of Gangster Granny, trained by Mrs John Harrington, reported to the Clerk of the Scales that his mount was slowly away from the stalls and leaned right throughout.

219H Salthill Hotel Irish European Breeders Fund INH (Mares) Flat Race The Raceday Stewards enquired into an incident on the home bend involving Cailin Deas, ridden by Mr R.W. Barron, placed fourth, Rainbow Connection, ridden by Mr L.P. Shanahan, unplaced, Run For The Border, ridden by Mr D. McGill, placed sixth, Something Fabulous, ridden by Mr F.R. Buckley, unplaced, and Brave Lady, ridden by Mr D. O'Connor, placed third, where it appeared interference may have occurred. Evidence was heard from the riders concerned. Mr. Barron said he received a bump from his inside. Mr. Shanahan said he did not feel much interference. Mr McGill said he received pressure from his inside. Mr. Brickley said he received slight interference from his from his inside. Mr. O'Connor said his mount cornered badly and ran off the bend causing the incident, however, he felt he made every effort to correct her. Having viewed the recording of the race and considered the evidence, the Raceday Stewards took no further action.

D.J. O'Keeffe replaced M.P. O'Connor on Nas Na Riogh, trained by Henry de Bromhead (Race 4) (intended mount a non runner)

220A Adare Manor Opportunity H'cap H'dle The Raceday Stewards enquired into an incident on the bend past the stands involving Castleheath, ridden by P.M. O'Brien, Battle Of Ridgeway, ridden by L.A. McKenna, Ragmans Corner, ridden by E. Finegan, Duleek Street, ridden by A. Harvey, Half A Chance, ridden by G. Brouder, Miss Dishy, ridden by S. Cleary-Farrell, and Jack Holiday, ridden by P.T. Smithers where it appeared an incident occurred. Evidence was heard from the riders concerned. P.M. O'Brien and A. Harvey both said they received pressure from their outside. L.A. McKenna felt he kept his line around the bend. E. Finegan said he was behind the incident and had to check. G. Brouder said he was outside Jack Holiday with lots of room when a horse moved from his outside causing him to rub and bump the horse on his inside. P.T. Smithers said he clipped a heel when it became tight from both sides. S. Cleary-Farrell felt he was keeping his line when he heard a shout. He added he did not think he had caused interference and then he pulled out. Having viewed the recording of the race and considered the evidence, the Raceday Stewards found L.A. McKenna and S. Cleary-Farrell in breach of Rule 214 in that they had ridden carelessly. Having considered their records in this regard, they suspended L.A. McKenna for eight days (third offence) and S. Cleary-Farrell for two racedays (first offence). S. O'Callaghan, rider of Pahlavi, trained by John Joseph Hanlon, reported to the Clerk of the Scales that his mount made a mistake at the third last hurdle.

220B Kenny Galway Peugeot H'cap H'dle
The IHRB Veterinary Officer examined Garnacho, trained by Mark Fahey, at the request of the Raceday Stewards and reported the animal to have a delayed recovery post race.

The IHRB Veterinary Officer examined Bitofajokelike, trained by E. McNamara, at the request of the Raceday Stewards and reported the animal to have suffered from heat stress post race.

The IHRB Veterinary Officer examined Arctic Gale, trained by Emmet Mullins, at the request of the Raceday Stewards and reported the animal to have an overreach on its left fore and a superficial wound on its right fore but was otherwise found to be post race normal.

J.W. Kennedy, rider of Howdoyalikeherhome, trained by Gordon Elliott, reported to the Clerk of the Scales that his mount hung badly left.

220C Kinlay Hostel S'chase The Raceday Stewards interviewed Thomas Gibney, trainer of Must Be Obeyed, concerning the conduct of this horse who was unruly at the start and refused to line up. Mr Gibney said his charge has always been difficult but that this was her last run as she is in foal. Having considered the evidence, the Raceday Stewards, using their powers under Rule 14(iii), suspended Must Be Obeyed from running for a period of 90 days. Mr. Justice Raymond Groarke recused himself from this enquiry.

220D Lord Hemphill Memorial H'cap S'chase
The Raceday Stewards enquired into an incident in the straight involving Sea Music, ridden by D. Meyler, placed fourth, and Arctic Fly, ridden by P. Townend, placed second, where it appeared interference may have occurred. Evidence was heard from the riders concerned. D. Meyler said his race was run when Arctic Fly made her move towards the rail. P. Townend felt he was clear when quickening passed Sea Music and made his way towards the stand side rail. Having viewed the recording of the race and considered the evidence, the Raceday Stewards took no further action.

220E Irish Stallion Farms European Breeders Fund Ahonoora H'cap The IHRB Veterinary Officer reported to the Raceday Stewards that Bravais (GB), trained by G.M. Lyons, had blood at both nostrils post race.

Nicola Burns, rider of Love Billy Boy, trained by Gerard O'Leary, reported to the Clerk of the Scales that her mount was very slowly away from the stalls.

S. Foley, rider of Zabriskie Point (GB), trained by Adrian McGuinness, reported to the Clerk of the Scales that his mount slowly away.

220F Irish European Breeders Fund Auction Series M'dn The Raceday Stewards enquired into possible interference in the straight involving Duke Of Cumberland, ridden by D. Browne McMonagle, placed third and Lucia Molly, ridden by R.P. Cleary, placed second, where it appeared that interference may have occurred. Evidence was heard from the riders concerned. D. Browne McMonagle said his horse drifted slightly left as Lucia Molly drifted towards him. R.P. Cleary said his horse drifted right for a stride before he corrected it. Having viewed the recording of the race and considered the evidence, the Raceday

Stewards made no alteration to the Judge's placings and took no further action.

220G Village Salthill H'cap R.P. Whelan, rider of Gangsta Man, trained by Kevin Michael Smith, reported to the Clerk of the Scales that his mount had no run.

N.G. McCullagh, rider of Highland Harvey, trained by A.J. Martin, reported to the Clerk of the Scales that his mount met with a little bit of interference at the furlong pole but it made no difference to its running. The Raceday Stewards reviewed the video evidence and were satisfied that the incident was caused by Highland Harvey running into the back of a retreating horse.

The Raceday Stewards informed David Loughnane (in GB), trainer of This Farh (GB), that his charge would have to be recertified before being declared to run from stalls again.
