Irish Horseracing Regulatory Board Notice

Declaration Of Non-Runners & Reserves

Trainers are requested to note that notifications of a non-runner or declaration of a reserve **can now be done via RAS** or on the dedicated telephone line (045-445645) at the Office of the I.H.R.B. up to 90 minutes before the time of the first race.

If using the Non-Runner/Reserve Telephone Line, the caller will be asked to provide the Trainer's Horse Racing Ireland account number and Trainer's date of birth. All calls are recorded for verification and security purposes. Veterinary certificates, where required, must be

sent as usual to the Office of the IHRB within 72 hours. A Trainer failing to lodge a certificate within the time period shall be liable to a fine in accordance with Rule 194(v)(vi).

Trainers wishing to declare a Reserve a runner or a non-runner must also do so **via RAS** or on the same dedicated telephone line number by **10am for meetings, (other than floodlit meetings) during the months of November, December and January** and by 11am for all other meetings including floodlit meetings otherwise the reserve will automatically be withdrawn.

If a rider has not been nominated for a declared reserve the Trainer must do so by the time fixed for declaration of a reserve listed within the paragraph above otherwise the declared reserve will automatically be withdrawn.

Declaration of reserves or of non-runners are no longer accepted at a race meeting.

Updates can be made **via RAS anytime after the publication of Rider Nominations for the meeting up to the specified deadlines.**

The dedicated line number (045 - 445645) is in operation from 9am on weekdays when there is a Race Meeting **and from 8.30am on weekends and Bank Holidays in November, December and January.**

Appeals & Referrals

Appeal

The Appeals Body, Mr Michael Hickey (in the chair), Mr John Murphy and Mr Nick Wachman convened at the Offices of the Irish Horseracing Regulatory Board on Wednesday, 02 April 2025 to consider the appeal of D J O'Connor (Rider) against the decision of the Raceday Stewards at Dundalk on 21 March 2025.

On the day, following the running of the Dundalk Stadium Winter Series Handicap, the Raceday Stewards found Mr O'Connor, rider of Sporting Hero, in breach of Rule 214 in that he had ridden carelessly and having considered his record in this regard (first offence), the Raceday Stewards suspended him for two racedays.

The grounds of the appeal lodged by Mr O'Connor were that the Raceday Stewards erred in their decision on the day.

At the appeal hearing, evidence was heard from Mr O'Connor. The Appeals Body also watched a recording of the race.

In his evidence Mr O'Connor stated that he felt he maintained his racing line throughout. Mr O'Connor confirmed that he had heard shouting from his outside and looked behind him but always felt that he kept his racing line and didn't feel he had caused any interference.

Having considered the evidence, the Appeals Body allowed the appeal.

The case was presented by Mr O'Connor, accompanied by Mr Niall McCullagh, Jockey Coach. The IHRB was represented by Ms Christine Traynor BL, IHRB Head of Racing Regulation and Integrity.

Appeal

The Appeals Body, Mr M C Hickey (Chairman), Mr Anthony Byrne and Mr John Murphy convened at the Offices of the Irish Horseracing Regulatory Board on Tuesday, 22 April 2025 to consider the appeal of Luke McAteer (Rider) against the decision of the Raceday Stewards at Leopardstown on 09 April 2025.

On the day, following the running of the Bulmers Live At Leopardstown Handicap, the Raceday Stewards found Mr McAteer, rider of Brownd Off, in breach of Rule 214 in that he had ridden carelessly and having considered his record in this regard (second offence), the Raceday Stewards suspended him for four racedays.

The grounds of the appeal lodged by Mr McAteer were that he believed he did not ride carelessly.

At the appeal hearing, evidence was heard from Mr McAteer and Appeals Body also watched a recording of the race.

In his evidence Mr McAteer stated that he corrected his mount after drifting away from the rail towards the horse on his outside. Mr McAteer stated that he believed there was not a sufficient gap for another horse to move up on his inside, so he corrected his position back towards the rail to prevent any potential interference caused by drifting outward and wasn't aware of any horse on his inside. Mr McAteer said he did not hear any shout from any riders behind him and believed that he did not cause any interference during the race.

Having considered the evidence, the Appeals Body dismissed the appeal and confirmed the breach of Rule 214. Having considered Mr McAteer's record, the appeals body reduced the suspension imposed from four racedays to three racedays.

The Appeal was presented by Mr Andrew Coonan of Coonan Cawley Solicitors, Naas, County Kildare on behalf of Mr McAteer. *The IHRB was represented by Ms Louise Troy BL instructed by Christine Traynor Head of Racing Regulation & Integrity and Mr Andrew Ring, IHRB Stipendiary Steward*

Appeal

The Appeals Body, Mr Martin P. O'Donnell (Chairman), Mr Anthony Byrne and Mr John Murphy convened at the Offices of the Irish Horseracing Regulatory Board on Monday, 28 April 2025 to consider the appeal of Mr Patrick A King (Rider) against the decision of the Raceday Stewards at Tramore on 14 April 2025.

On the day, following the running of the Gaultier Hunters Steeplechase, the Raceday Stewards found Mr King, rider of Revolut Ned, in breach of Rule 212(iv)(a) in that he failed to obtain his best possible placing as a result of misjudgement and having considered his clean record in this regard, the Raceday Stewards suspended him for five racedays.

The grounds of the appeal lodged by Mr King were that while accepting that he mistook the winning post his mount was tiring and was passed by a fast-finishing horse and that his error did not cause him to lose second place.

At the appeal hearing, evidence was heard from Mr King and Mr William P Murphy, Trainer of Revolut Ned. The Appeals Body also watched relevant recordings of the race.

In his evidence Mr King stated that he sat up for a few strides and then quickly continued to ride out to the line and believed this mistake did not cost him a placing. Mr King explained that the horse had previously not finished out his races and added that his mount had recently had wind surgery.

In his evidence, Mr Murphy explained he trained this horse for three years and the horse had undergone its second wind surgery recently. Mr Murphy said in his opinion and with the benefit of hindsight the horse may have needed another week before running. Mr Murphy stated he was typically a weak finisher and that they had changed tactics for this race to ride him more prominently.

Having considered the evidence, the Appeals Body dismissed the appeal and confirmed the decision of the Raceday Stewards.

The Appeal was presented by Mr Andrew Coonan of Coonan Cawley Solicitors, Naas, County Kildare on behalf of Mr King. The IHRB was represented by Ms Louise Troy BL instructed by Christine Traynor Head of Racing Regulation & Integrity and Mr Andrew Ring, IHRB Stipendiary Steward.

Appeal

The Appeals Body, Mr Martin P. O'Donnell (Chairman), Mr John Murphy and Mr Raymond J McSharry convened at the Offices of the Irish Horseracing Regulatory Board on Wednesday, 14 May 2025 to consider the appeal of Mr Patrick Mullins (Rider) against the decision of

the Raceday Stewards at Punchestown, 03 May 2025.

On the day, following the running of the DAR Golf (Pro-Am) INH Flat Race, the Raceday Stewards found Mr Mullins, rider of Quantum Boy, in breach of Rule 214 in that he had ridden carelessly and having considered his record in this regard (second offence), the Raceday Stewards suspended him for four racedays.

The grounds of the appeal lodged by Mr Mullins were that he believed he did not ride carelessly.

At the appeal hearing, evidence was heard from Mr Mullins and the Appeals Body also watched a recording of the race.

In his evidence Mr Mullins accepted that his mount did lean in slightly, however he corrected the horse immediately as best he could but there was no room on his outside to move into. Mr Mullins stated that he believed there were no reasonable steps he could have taken to avoid interference.

Having considered the evidence, the Appeals Body dismissed the appeal, confirming the breach of Rule 214 and upholding the decision of the Raceday Stewards.

The Appeal was presented by Christine Traynor Head of Racing Regulation & Integrity and Mr Leighton Aspell, IHRB Stipendiary Steward.

Appeal

The Appeals Body, Mr M.C. Hickey (Chairman), Mr Anthony Byrne and Mr John Murphy, convened at the offices of the Irish Horseracing Regulatory Board on Tuesday, 22 April 2025, to consider the appeal of Mr Sean Staples (Rider) against the severity of the sanction imposed on him by the Acting Stewards at Killeady (H), Dromahane Point to Point on 13 April 2025.

On the day, following the running of the 5yo & Upwards Geldings Maiden, the Acting Stewards found Mr Staples, rider of Guseakie, in breach of Regulation 58.3(b). Having considered his record in this regard, the Acting Stewards suspended him for four Point to Point racedays.

At the appeal hearing, evidence was heard from Mr Staples. The Appeals Body also watched a recording of the race and considered a written submission from Dr Jennifer Pugh, IHRB Chief Medical Officer.

In his evidence Mr. Staples stated that he used his whip after the last fence to ensure his mount maintained a straight line to the finish. He stated that, although this was the horses first run, he was familiar with him from riding him out at home and he was conscious that the horse may run towards the area where the horseboxes were located. Mr. Staples accepted he was in breach of Regulation 58.3(b), but believed the suspension imposed was excessive. Mr Staples stated that he has been actively working on improving his riding technique to prevent similar incidents in the future and to this end he had recently purchased a riding simulator.

Having considered the evidence, the Appeals Body reduced the suspension to one Point to Point Raceday and ordered Mr Staples to attend RACE for one day tuition on the correct use of the whip.

The case was presented by Mr Staples. *The IHRB was represented by Ms Louise Troy BL*

instructed by Christine Traynor Head of Racing Regulation & Integrity and Mr Andrew Ring, IHRB Stipendiary Steward.

Suspension Day: 27 April

Appeal

The Appeals Body, Justice Siobhan Keegan (in the chair), Mr John Murphy and Mr Nick Wachman convened at the Offices of the Irish Horseracing Regulatory Board on Monday, 26 May 2025 to consider the appeal of T M Walsh (Trainer) against the decision of the Raceday Stewards at Wexford on 17 May 2025 following the T.C. Cullen Memorial Novice Steeplechase.

On the day the stewards enquired into the running and riding of Ta Na La (USA), ridden by S. O'Callaghan, and trained by T M Walsh. The Stewards found Mr Walsh and Mr O'Callaghan in breach of Rule 212A(ii), in that the rider was not seen to have attempted to obtain from his mount timely, real and substantial efforts to achieve the best possible place. Having considered their records in this regard, the Raceday Stewards fined Mr Walsh €3,000 and suspended Ta Na La from running for 60 days under the provisions of Rule 212C(D).

The grounds of appeal lodged by Mr Walsh were that he believed he was not afforded the opportunity to state his case on the day through his Authorised Representative and that under no circumstances was Shane O'Callaghan instructed not to obtain from Ta Na La a timely, real and substantial effort to achieve the best possible placing.

At the appeal hearing, evidence was heard from Mr Walsh on a *de novo* basis and the panel viewed a recording of the race.

In his evidence, Mr Walsh confirmed that he was unable to attend the races on the day and that Mr Brendan Brady had travelled with Ta Na La as his Authorised Representative. Mr Walsh explained that he had opted to run in this race at Wexford instead of running in a bigger field and felt it would suit for her first start over fences. Mr Walsh stated that the ownership of Ta Na La had been taken over from the previous owner and that the mare has won one race from 28 starts with her level of ability being clear from those runs. He added that he hoped Ta Na La would put in a clear round of jumping and settle and if she did that would pick up some prize money. This was her first start since returning from a break as she prefers summer ground conditions and Mr Walsh added that his instructions to Mr O'Callaghan were to settle her behind runners as she can run freely and to give her confidence jumping. Mr Walsh confirmed he was satisfied with the ride his mount had got until they reached the final fence. Mr Walsh stated that he had instructed Mr O'Callaghan not to use his whip in the event that Ta Na La was going to be well beaten and he didn't want her to fall on her chasing debut but stated that she had outrun expectations given the ratings of the other two horses and while he was delighted with the career best performance of Ta Na La, he felt from the last fence Mr O'Callaghan, although achieving his best possible position, didn't make enough effort to show the racing public that he was achieving his best possible position. Mr Walsh accepted that Mr Brady was his Authorised Representative on the day, but he hadn't spoken to him at length about the race in particular as Mr Brady provides raceday help as a lifelong friend and is not an employee.

Having considered the evidence, Justice Siobhan Keegan read out the following decision on behalf of the Appeals Body.

"We have considered what was put to us by Mr Power, on behalf of Mr Walsh, we have considered Mr Walsh's evidence and we have considered what Ms Traynor has said on behalf of the IHRB.

In considering whether the Raceday Stewards have erred in applying, what are the minimum penalties for a breach of Rule 212A, a fine to the Trainer of €3,000, a minimum suspension of the Horse for 60 days and a minimum restriction on the Rider for 14 days, we bear in mind that there is no appeal pursued in relation to the Rider.

Secondly, we bear in mind the terms of Rule 212A(ii), which is a rule in relation to non-trying and it is obviously an important rule for that reason.

Just to be clear, the rule states: *Any Rider or other person who either rides a Horse in a Race or causes, contributes to or permits the running and/or riding of a Horse in a Race in such a way that the Horse cannot be seen to have been the subject of a genuine attempt to obtain from the Horse timely, real and substantial efforts to achieve the best possible place shall be guilty of an offence under this sub-rule.*

There has been no issue taken by the Rider's and indeed Mr Walsh's position that that rule has been breached. Therefore, the Raceday Stewards on the day were correct in relation to that.

The next rule that needs to be looked at is Rule 212C(d) which states: *Where the Raceday Stewards, having considered the performance of a Horse in a Race and any other relevant circumstances, find that the Horse was run and/or ridden in breach of any sub-rules set out in Rule 212A... may consider that the horse concerned should be restricted from participating.*

The minimum sanction here is 60 days suspension. We can't see that the Raceday Stewards have erred in their application of a restriction on the horse having found that the Rider is in breach, so we uphold the suspension of the horse involved.

Now, the final aspect of the case, however, is the issue of Mr Walsh's position. We have listened carefully and reflected on what he has said to us. Clearly, in his opinion, he was dissatisfied with the ride. He accepts a breach of the rules in respect of Mr O'Callaghan.

We have had the benefit of hearing from Mr Walsh, which the Raceday Stewards on the day did not have. In this case, we acknowledge that the Authorised Representative was not asked whether they were satisfied with the ride accordingly we accept Mr Walsh's evidence today and find that the Trainer in this circumstance is not in breach of the rule and therefore we are going to remove the fine on Mr Walsh, which was the minimum fine of €3,000.

It's accepted by Mr Walsh that the provision of instructions given to his Authorised Representative were not of a standard that, on the face of it, were in within the rules. While no formal charges were put to Mr Walsh under rule 147(v) the Appeals Body reminds Mr Walsh of his obligations in this regard, and it serves as a clear reminder that appropriate instructions must be given in future cases.

Mr Walsh's appeal succeeds, and he should have his deposit returned.

The appeal was presented by Mr Kevin Power of Maurice Power Solicitors, Kilmallock, County Limerick on behalf of Mr Walsh. The IHRB was represented by Ms Christine Traynor, BL.

Referral

The Referrals Committee, Mr Michael Hickey (Chairman), Mr Anthony Byrne and Mr John Murphy convened at the Offices of the Irish Horseracing Regulatory Board on Tuesday, 25 March 2025, to consider an objection by a Senior Racing Official in accordance with the provisions of Regulation 48(i)(c) of the Irish National Hunt Steeplechase Regulations, regarding the eligibility to ride of Mr Charlie Mullins, rider of Step Up Son, placed second, in Race 5, the *Kirbys Pharmacy Open Lightweight (Novice Riders)* at the Scarteen (F) Comea Point to Point on Sunday, 9 February 2025.

The application arose following an investigation by the IHRB into whether Mr Mullins, rider of Step Up Son met the qualifications required to ride in the race, which was confined to Novice Riders, as outlined in the race entry conditions.

At the Referrals Committee hearing, evidence was heard from Mr Mullins and Mr Ray Bergin, IHRB Point to Point Operations Manager.

In his evidence, Mr Mullins admitted that he was not familiar with the qualification rules for Novice Riders in Point to Points, as he does not frequently ride in Point to Point races. He stated that the misunderstanding was a genuine mistake, apologised and accepted that he was in breach of the relevant Regulation.

In his evidence, Mr Bergin stated that Mr Mullins had ridden 16 career winners prior to the closing of entries on Tuesday 4 February for the Scarteen (F) Comea fixture which included 14 wins on the racecourse and two Point to Point winners. He further stated that currently, only those riders, who have not ridden more than 15 winners under any Rules of Racing or Steeplechasing, including Point to Point Steeplechases prior to the closing of entries, are qualified to ride in races confined to Novice Riders.

Having considered the evidence, the Referrals Committee considered that under Regulation 1(i), which defines a Novice Rider, that Mr Mullins was in breach of Rule 87(i)(h), in that he was not qualified to ride in Race 5, the *Kirbys Pharmacy Open-Novice Riders* at the Scarteen (F) Comea Point to Point and imposed a fine of €150. The Referrals Committee also ordered that Step Up Son be disqualified from the race in question and the result of the race be amended to read as follows:

Scarteen (F) Comea Point to Point – 9 February 2025

Kirbys Pharmacy Open - Novice Riders

First: Boss Robin

Second: Robbin'hannon

Overnight Nomination Of Rider & Colours
