Rules or Rules of Racing other than one, two or three I.N.H. flat races or N.H. flat races or a combination of such races and which had been offered in the Goffs Land Rover National Hunt Sale of August 4th and 5th, 2020 (Lots 1-532 inclusive) or had been catalogued in that sale and withdrawn and offered for sale at the Goffs UK 2020 Summer Sale, and have been declared by Goffs Bloodstock Sales Ltd. as being eligible to enter and run in accordance with the relevant Conditions of Sale. Horses which do not have a registered name and are not Returned In Training with a Licensed Trainer by Wednesday, 24th March, 2021 will be automatically struck out of this race. (Please note for Irish and British bred horses, trained in Ireland, an acceptable naming application should be made to HRI by Thursday, 18th March, 2021 at the very latest. For all other foreign bred horses, trained in Ireland, naming applications will take longer to process)

€300 extra (plus €42.50 bookage fee) if forfeit not declared by 3rd February, 2021,

€300 extra (plus €42.50 bookage fee) if forfeit not declared by 22nd April, 2021

Weights 4-y-o11st 6lb; 5-y-o.....12st 2lb; Mares allowed 7lb

Riders - Qualified Riders under I.N.H.S. Rules. Allowances to riders under Rule 52 (iii) may be claimed in this race. HRI Directive 10 (ii) (c) is suspended for the purpose of this race. The Stewards of the I.N.H.S. Committee, using their powers under Rule 22 have suspended the appropriate paragraphs of Rules 103 (i), 106, 121 and 122.

Should it be necessary to reduce the number of declared runners to maximum runners or to such a lesser number as may be required the following procedures shall be applied for the elimination and balloting of horses:

(i) Runners will first be reduced by balloting from among those horses that have not run in an INH Flat race, a N.H. Flat race, a Hurdle race or a Point-to-Point Steeplechase in Ireland or Great Britain prior to Thursday, 22nd April, 2021.

(ii) In the event of (i) not achieving the recommended limit, runners will then be reduced by balloting from among those horses that have not been placed first, second, third, fourth or fifth in an INH Flat race or N.H. Flat race, second, third, fourth or fifth in a Hurdle race or first, second, third or fourth in a Point-to-Point Steeplechase in Ireland or Great Britain prior to 22nd April, 2021, with the order of elimination at the discretion of the N.H. Handicapper.

(iii) In the event of (ii) not achieving the recommended limit, the elimination of the remaining runners will be at the discretion of the N.H. Handicapper. The Handicapper's decision shall be final. (International performances will be taken into account and the latest date for assessment by the Handicapper will be 10 a.m. on Thursday, 22nd April, 2021).

N.B. All entry & forfeit fees will be refunded to the owners of those horses that are eliminated from this race.

The winning Owner will receive a trophy of no intrinsic value presented by Goffs Bloodstock Sales Ltd. Goffs/Land Rover will present €130 to the groom in charge of the best turned out horse in this race.

Owners who do not have a current racing account should include cheque for €412.50 (including bookage fee of €12.50) for each entry.
