Horses which do not have a registered name and are not Returned In Training with a Licensed Trainer by Wednesday 20th July, 2022 will be automatically struck out of this race. (Please note for Irish and British bred horses, trained in Ireland, an acceptable naming application should be made to HRI by Thursday, 14th July, 2022 at the very latest. For all other foreign bred horses, trained in Ireland, naming applications will take longer to process)

€1,000 to enter (plus €12.50 bookage fee),

€2,000 extra (plus €42.50 bookage fee), if forfeit not declared by 20th July,

€3,000 extra (plus €42.50 bookage fee) if forfeit not declared by 20th September,

In order to facilitate those people wishing to make entries for this race, the Stewards of the I.H.R.B., using their powers under Rule 22, have suspended the appropriate paragraphs of the following Rules, Rule 103 (i), 106, 121, 122 and 194(ii)(c). Should it be necessary to reduce the declared runners to the maximum runners, or to such lesser number as may be required the following procedures shall be applied for the elimination and balloting of horses:

(i) Runners will be reduced by balloting from among those horses that have not run.

(ii) In the event of (i) not achieving the recommended limit runners will then will be reduced by balloting from among those horses that, in the opinion of the Handicappers, have the lowest adjusted ratings (having regard to the applicable sex allowance). International performances will be taken into account. The latest date for calculation of ratings is 10 a.m. on Tuesday, 20th September, 2022.

Bonus

Goffs will pay a €100,000 bonus if the winning horse of this race goes on to win any Group/Grade 1 race under any Rules of Racing in Australia, France, Ireland, UK or USA as a 3-y-o. The bonus will be paid to the winning owner of the horse at the time of the Group/Grade 1 win. In the event of a dead heat for first place in this race, the bonus will be split evenly if the winning horse/horses go on to win an applicable Group/Grade 1 race in any of the countries listed above as a 3-y-o. The bonus will be paid to the winning owner of the horse/horses at the time of the Group/Grade 1 win.

All entry & forfeit fees (€6,000) will be refunded to the owners of those horses that are eliminated from this race.
